



NC UDPRB

Update of Activities: February 2020

- 258 Cases heard since initiated in 2014.
- A memorandum of understanding in place with Deputy Attorney General for legal counsel to the UDPRB.
- 200,000 being billed out to top 50 NC 811 transmission recipients.
- A memorandum of understanding in place with Department of Commerce for placement of funds received.
- Reminder: Facility Owners, Excavators and Notification Center are the ONLY parties that may be named in a complaint.
- NC 811 providing research to all complaints received after October 1, 2019.
- To date, 77 recommendations have resulted in orders being issued by NC Utilities Commission.
- Once funding is received, next steps are to secure administration through an rfp process and to develop a dedicated UDPRB web page.

Meeting opened at 9:05 am.

Town of Wadesboro-

New sewer line on US 74. Road closing at Anson/Pearl due to a collapsed storm drain. It is 25' deep. Has water/sewer work to do but need easements approved. Having an issue getting phone drops located by Windstream. (Checked with Integrity. They will locate phone drops but Windstream screens tickets before they do and they do not get many of them. Let them know and they will locate.)

NCDOT-

In Lilesville on US74/Camden Road at the elementary school, center islands and a bulb out will be going in. No left turns. Probably will not go in until 2021 due to budgetary constraints. Having some issues with paint going down with Anson County and Lilesville. No hooking up just putting paint down. When updates are going out everyone is notified. They only need one entity to be notified. Bridge at 109/State Line-project has not started yet.

PeeDee Electric-

Still working on pole replacements. Bio gas plant is still on the schedule. Few more poultry houses are going in. PeeDee will be constructing a new facility in Lilesville within the next three years.
