




BURIED

Stop all work immediately, Do not attempt to clear blockage with a mechanical device, Call operator immediately

Introductions around room.

PeeDee Electric- Routine underground/primary services going on. No issue with locates. Doing pole replacements in Wadesboro. Doing pole replacements in Union Co on White Store Road. Construction work plan-Stanly Co. Plank Road/Davis Road. Lots of bridge work. PeeDee has three substations in Marshville.

PNG- Retiring services. Sign surveying (looking for plastic markers to make sure they are in place. Doing leak surveys. They use a RMLD (remote methane leak detector). Looks like a radar gun. They are doing trouble shooting for mills in and around Rockingham. Shoots 200' in the air. The battery-operated detector has a laser that scans for leaks. Can pick up minute amounts.

30" Pembroke to Duke plant in Hamlet. 33 miles of pipe to lay (first of year)

Windstream- Project behind Walmart. Putting in fiber. They are almost complete. There are businesses around the location that could tap off of this connection. Have a large project upcoming in Norwood, mid-November. Lucky Clay Farms. Solar fields. Lady has a battery room, wellness cabins, tennis courts, shoot clay. Large facility. For damages, still call in to call center. Damage crew has to be on site for emergency call w/in 2 hours. Globe communications is their contractor. Ryan Zapp/Steven Jolly are the two supers in that area. *FYI-cell towers are being hit. Thieves are stealing batteries to sell. (800# for call outs for Windstream damages 1-800-347-1991)

Town of Wadesboro- Getting ready to start project on the new interconnect. Communications co putting in fiber from 52 down to old radio station. Need to get encroachments from the town and DOT. KFC project is moving along. The plan is to be opened before Christmas. Hope to be in new fire station before the end of the year. Unknown what Town will do with old station. Council has been discussing for several months.

The Anson Ag center is still an ongoing project. No details. It was supposed to be completed in 2018.

Median project from 109 to the mini mart-putting in grass median. \$11,000,000 project.

Hugh said one issue they are having is bleed over when locates are being done.

PNG/Windstream say they are both still having issues with companies marking with wrong colors (Moore Co)-Pinehurst.

NC811 presentation given by Tami Stout

David Burr spoke about an incident on September 1st at their facility. Was for co-ops. Four primaries on the pole with 4, 14,400 volts. Contractor boring got head of machine into a pipe and cut one of the primaries. David went across the street and cut off the other three. The locates were accurate, everything was going along properly, however the machine operator was 2' below where he was supposed to be. David said he had a serious discussion with the contractor. The incident could have been much worse. However, the equipment was shut off immediately.

Spoke about the LRPC and what they have been trying to accomplish.

There are power poles called in for locates that have no address-just a pole number. The caller will use between two streets.

Meeting for December cancelled (on Christmas day).
