

NC UDPRB

Update of Activities: February 2020



- 258 Cases heard since initiated in 2014.
- A memorandum of understanding in place with Deputy Attorney General for legal counsel to the UDPRB.
- \$200,000 being billed out to top 50 NC 811 transmission recipients.
- A memorandum of understanding in place with Department of Commerce for placement of funds received.
- Reminder: Facility Owners, Excavators and Notification Center are the ONLY parties that may be named in a complaint.
- NC 811 providing research to all complaints received after October 1, 2019.
- To date, 77 recommendations have resulted in orders being issued by NC Utilities Commission.
- Once funding is received, next steps are to secure administration through an rfp process and to develop a
 dedicated UDPRB web page.

Brian Morehouse went over the February 2020 presentation giving the totals for YTD and Monthly number for Tickets called in, average locates per day and (3) hour tickets.
