- Also, please communicate to him any issues we may continually have that is causing delays in get the locates done in a timely fashion.
- The month of June is "Safety Month". The video for the month covered many of the things we come into contact on a daily basis that we do not think about. Some of these are listed below:

- Remote Tickets: Everyone needs to start using the Remote Ticket request from the App. It is a lot faster, and very easy to use. The DOT is beginning to use the NC811 App to set up locates. IF you see any problems in using the APP, let Brian know so he can address with those that may need to know. Also remember, that you can follow-up on

your requested locates and those locates around you. This way you are always informed!


