That county members are identified on the NC 811 App. If you have not downloaded this app onto your smart phones, you need to do so. This is a most valuable tool especially when you are in the field and need to communicate with NC 811.

There has been a lot of new laws that have begun as of October 1, 2019 relating to damages and how to handle underground utilities.

Damage Reporting: Remember that if you damage an underground utility, it is <u>your</u> <u>responsibility to report this damage to NC 811 UCC. Offices in Greensboro</u>.

If you are using the NC 811 "app" on your smart phone, you now have the ability to submit an emergency request of a locate. This should greatly speed up getting these locates done in a timely manner.

Finally, if you have a complaint concerning damages to your system by someone. It is your responsibility submit the report for those damages. NC 811 can not make the report for you!

Round-table Discussions:

Will Ellis & Ronnie Suttles – City of Morganton: A lot of new taps for water and a lot of Housing development being work on at the present time. Longhorn Steak House has been construction on South Sterling Street across from the Hospital/

Kevin Pritchard & Derek Goble – City of Lenoir: Lenoir too is experiencing a lot of new growth. Several housing developments and a new Hampton Inn is being built.

Doug Suttles – Suttles Surveying: Still staying very busy. They are still working on the DOT bridge replacement for the Sugar Hill Road crossing I-40 in McDowell County. Very hard to find new employees, this is causing delays in getting new work started.

<u>Ralph Johnson – Brentwood Water:</u> We continue to stay very busy. We have experienced a problem with plastic pipe failure in one area of our system. This pipe was installed around

eighteen years ago. The problem is that the hubs are cracking causing leaks to the system. The repair clamps currently being used cost around \$200/each. We have 8 repairs in about ½ mile line. We are in the process of getting bids to make a total replacement of this line.

<u>Jeremy Hussey – USIC – Caldwell County:</u> Jeremy reports that he has been able to secure some new employees. Very shortly, he should be able to report that things are much better for USIC in Caldwell County.

Copy of Information for Recently adopted House Bill 872 – Effective October 1, 2019



Definitions

- 87-117 (1a) Board The Underground Damage Prevention Review Board
- 87-117 (18a) Parcel An extended area of land with fixed boundaries

Notification Center

- 87-120 (a) & (c) Notification Center removed from receiving, maintaining and providing general administration of reports of alleged violations.
- 87-120 (c) (9) Notification Center shall have the duties to provide information requested by the UGDPRB in consideration of reports of alleged violations.

Facility Operator

- 87-121 (a) (1) The dimension of the pipe shall be indicated every 50 feet if the diameter or width of facility is greater than four inches.
- 87-121 (a) (1a) The operator's identity marked in the area where the proposed excavation or demolition is to occur. At a minimum, beginning/intervals of 200 linear feet/end.

Excavator

- 87-122 (b) (5) a. A single parcel that may exceed ¼ mile in linear length identified by a single address.
- 87-122 (b) (5) b. The lesser five adjoining parcels identified by addresses, not to exceed ¼ mile in linear length or an area not to exceed ¼ mile in linear length.
- 87-122 (c) (6) Three hour notices additional notice (allows for on-line submission)
- 87-122 (c) (10) Gas, oil, petroleum an electric transmission line has been expanded to read oil, petroleum
 products, or highly volatile liquid pipeline system, a gas transmission line, or an electric transmission line. No
 mechanized equipment within 24" of a facility unless the facility operator has consented to the use in writing
 and the operator's representative is on site during the use of the mechanized equipment.

Exemptions

- 87-124 (6) An excavation or demolition performed when those responsible for routine maintenance of a right of way or any other governmental entity are performing, with labor on their permanent payroll, maintenance activities within the right-of-way.
- 87-124 (6) Drainage structures are not included in maintenance activities.
- 87-124 (6) The provisions do not apply when the excavation or demolition is performed by a contractor acting on behalf of a person or entity responsible for routine maintenance of a ROW or on behalf of any other governmental entity.

Emergency Excavation

- 87-125 (a) Emergency excavation give notice (allows for on-line submission)
- 87-125 (c) Any person who falsely claims that an emergency exists requiring an excavation
 or demolition shall have violated the provisions of this Article, which shall be punishable as
 a Class 3 misdemeanor and may subject the violator to the imposition of penalties or other
 action to be taken by the Board pursuant to G.S. 87-129.

Design Notices

 87-127 (a) (1) & (3) proposed area of excavation removed – area designated by the design notice

Underground Damage Prevention Review Board; enforcement; civil penalties

- 87-129 (b) All reports will be submitted to the Board Notification Center removed from the process
- 87-129 (b1) The Board shall approve training courses and the sponsors of those training courses. Any fees for training courses will be paid by the person determined to have violated this Article.
- 87-129 (e) The Board is authorized to employ contractors or other personnel as it may deem necessary to carry out the provisions of this Article.
- 87-129 (f) Board shall maintain record of reports of alleged violations for at least four years.
- 87-129 (g) On request of the Board, the Attorney General's office shall assign a legal representative to provide legal counsel.
- 87-129A Board is authorized to impose an annual fee on operators in order to fund activities and
 operation of the Board in reviewing reports of alleged violations not to exceed \$200,000 annually.







If the diameter or width of the facility is greater than four inches, the dimension of the facility shall be indicated at least every 50 feet in the area of the proposed excavation or demolition. An operator who operates multiple facilities in the area of the proposed excavation or demolition shall locate each facility.

The operator's identity, marked as provided in subdivision (1) of this subsection, in the area where the proposed excavation or demolition is to occur. At a minimum, the operator's identity shall be marked at the beginning point, at intervals of 200 linear feet, and at the end point of the proposed excavation or demolition.
