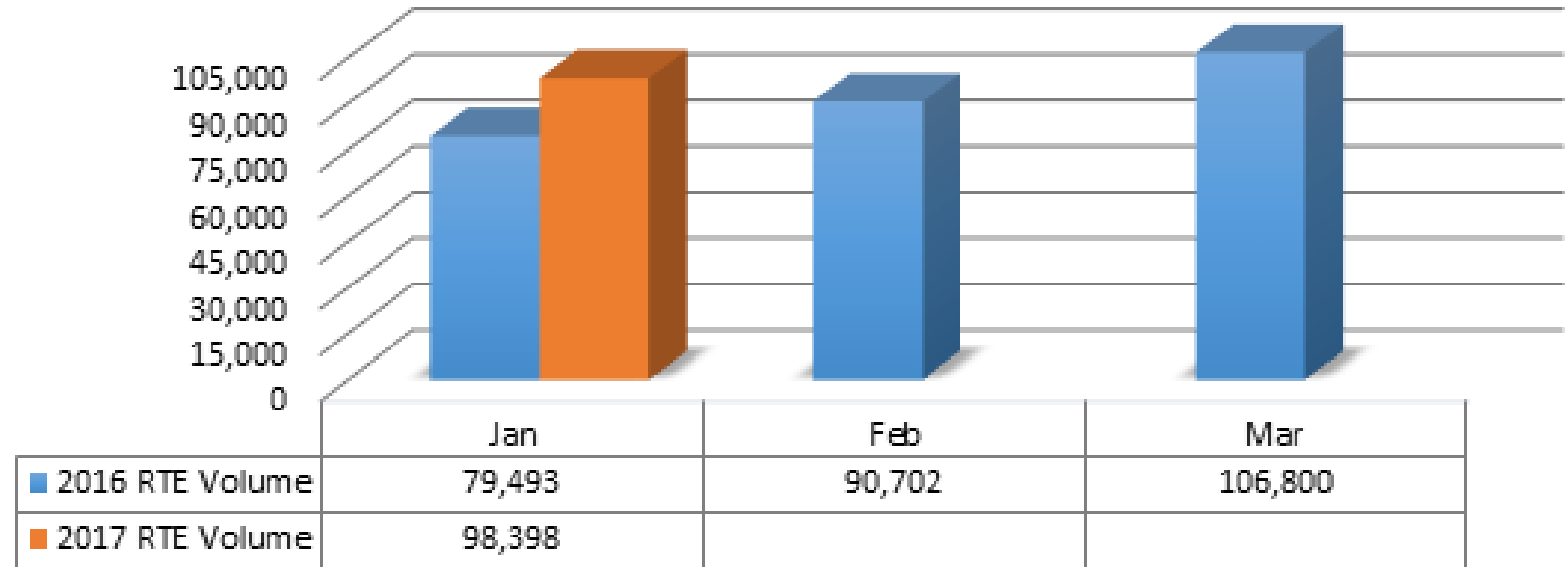

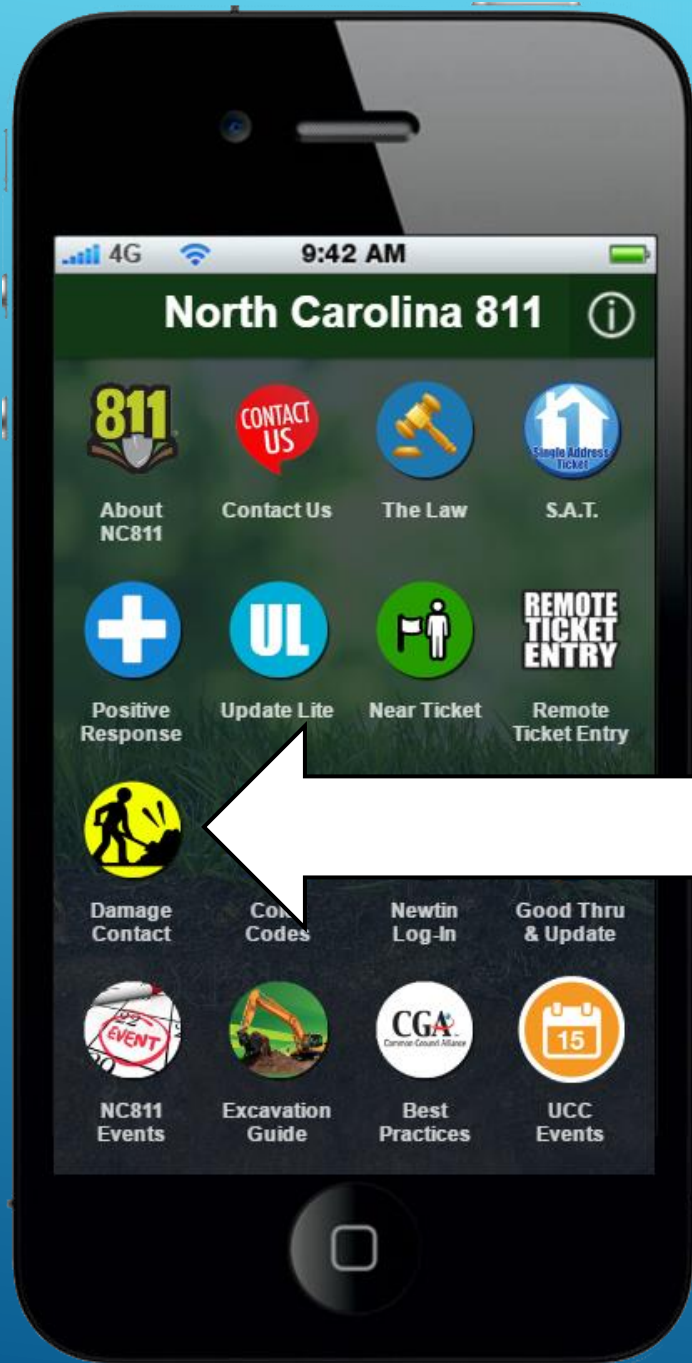

 - 6 were found to be not violations
