Member Project Discussions:

Jeff Bartley with NC811 went over important information such as:

- Ticket volume for Cumberland County.
- 75 Year Anniversary for UCC
- Pipes Plus is now available in Spanish (available online or at your facility)
- Explained how the NC Underground Damage Prevention Review Board process works.

I have attached Jeff's narrative for your reference.

Jeff also showed a brief video update reviewing 2016 as well as information such as:

• The City of Raleigh was recognized as the Safe Digging Partner of the Month

Bill Hammond with NCDOT was unable to attend however I have attached his NCDOT project list.

Jeff Riddle with the City of Fayetteville stated the City Resurfacing List is in pre-bid at this time. Riley Road Storm Drain Project will be starting soon. Bonnie Doone Storm Drain Project bids are due in January.

Marc Tunstall with PWC Electric Construction stated they were running lines in Shenandoah and Beaver Run. They are also still working on Hurricane Matthew restorations.

Tony Mlynski with Charter Communications stated the work on relocating the fiber cable crossing in Hope Mills Lake is ongoing. Force relocate project for Bragg Boulevard is also ongoing.

Douglas Ward with Piedmont Natural Gas stated they are still working on gas line replacement on Bragg Boulevard. Line work is being conducted in Cottanade Subdivision, Braxton Rd & Chickenfoot Road. Also, there are a lot of retirements being completed due to damage caused by Hurricane Matthew.

Joe Kulwicki with Distribution Construction stated they are working on Bragg Boulevard and Cottonade Subdivsion.

Kenny Hart with PWC Water Resource Construction stated the water main rehab contractors are to return in mid-January 2017. Sandy's Hauling & Backhoe Service is currently replacing the water main on Coley Drive. Hurricane Matthew storm recovery is ongoing. PWC crews are also working on water and sewer lateral renewals on Swann Street.





NC Underground Damage Prevention Review Board Process

Complaint received,
response sent within
10 days, response material
compiled, case number
assigned

Board reviews the information provided by the parties and determines whether a violation occurred or if there is insufficient evidence. Action or penalty is determined.

Certified letter is sent to the parties indicating the outcome and that the violator has 30 days to request a hearing from UDPRB if they disagree.

If a hearing is requested, the UDPRB will place it on the calendar for a future meeting and notify both parties.

If no response within 30 days, case is docketed with Utilities Commission and an order is issued.

If penalty is upheld, case is docketed with the Utilities Commission and an order issued.

Any future appeals are handled directly through arbitration.

An order issued from Utilities Commission from arbitration, may be appealed to the superior court division of the General Court of Justice in the county of alleged violation or in Wake County

The party cited with a violation will have (90) days to comply with the training requirement once docketed by the Utilities Commission. Their order will explain the details of compliance for fines and training to the individual receiving the order.





NC Underground Damage Prevention Review Board Process

Complaint received,
response sent within
10 days, response material
compiled, case number
assigned

Board reviews the information provided by the parties and determines whether a violation occurred or if there is insufficient evidence. Action or penalty is determined.

Certified letter is sent to the parties indicating the outcome and that the violator has 30 days to request a hearing from UDPRB if they disagree.

If a hearing is requested, the UDPRB will place it on the calendar for a future meeting and notify both parties.

If no response within 30 days, case is docketed with Utilities Commission and an order is issued.

If penalty is upheld, case is docketed with the Utilities Commission and an order issued.

Any future appeals are handled directly through arbitration.

An order issued from Utilities Commission from arbitration, may be appealed to the superior court division of the General Court of Justice in the county of alleged violation or in Wake County

The party cited with a violation will have (90) days to comply with the training requirement once docketed by the Utilities Commission. Their order will explain the details of compliance for fines and training to the individual receiving the order.
