 Phillip Callahan discussed general safety issues. He provided the info that 80% of accidents happen due to an unsafe act and not an unsafe condition. He discussed items such as hurried or preoccupied workers and the influence of negative attitudes on the work site.

- Justin Lollis discussed facility damage reports and explained that one could use DIRT Lite to report damage to their own facility but damage to another entity's facility need to be called in to NC 811.
