Leslie O'Connor with Durham City/ County Emergency Management said they are in the process of re-writing emergency operation plans and FEMA restructuring. She requested everyone's information or business cards.

Tasha Johnson with City of Durham Public Works discussed permitting & locates and changes in some of their processes to be more flexible to utility needs and contractor needs.

Bill DeBruhl with DCC asked if anyone knew of someone that could get some fill dirt and also they have a new supervisor we will be seeing around Scott Chasin.

TRC said that work is picking up.

Tom Miller with ITS asked about the rules in regards to calling in multiple addresses if only need the ROW marked how many is within correct locate ticket parameters because they are getting some comments about it.

Some of the companies gave some examples and some people discussed what they are finding is acceptable with regards to marking in white paint and putting specific addresses and areas on the ticket.

Southern Cross said they thought there was going to be some verbage changed due to the footages might be more/ less depending on the county and house sizes.

Steve said that they are going to be having a video for white lining & how to do it correctly with the CGA best practices.


