Meeting Time:

The Durham County Utility Coordinating Meeting was called to order by Kenneth Knighton at 11:00 am.

Total Members Present:

There was a total of **24** members present at the February Durham County Utility Coordinating Meeting.

Safety Moment:

Scott Parker with PSNC Energy provided a safety moment for this meeting. Scott talked about hit lines and who to notify and how if you have a damaged gas line you must call the utility you hit and also the UCC 811 to get an emergency locate and you CAN call 911 if needed. If you smell gas it's a good idea to stop working so as not to cause more damage and for safety reasons. Scott talked about a 4" gas main hit that was caused more damage due to pull back on back reaming rods & instead of stopping they continued working which caused more damage that could've been prevented. Also please make sure to call if you damage a tracer wire because on plastic pipe that is how you locate it in the ground and we will come and fix that back no problem.

Jeff Bartley: He talked about it's the UCC's 75th anniversary and there will be a celebration and they will handing out t-shirts for everyone and took up shirt sizes.

Jeff Bartley: Talked about the underground review board if you have a complaint you can send it into the board to review and give the evidence to them to investigate and they will notify that violator within 10 days and you will get a case number, the person can be fined up to \$500.00 per component. The money goes to the Education Fund.

Jeff talked about the Damage contact APP and how to use it to find persons that have called in a locate ticket within the--- so many feet radius so you can find out who is doing work in the area. It goes by the area GPS on your phone.

We found out that it's up to the person doing the construction to get the grids for the mapping 811 system to 811 so it can be put on the map if there is a damage in a NEW area it can still be called in and found.

If it does not have an address you must white line the area to help narrow the area to be located by tickets.

Board meetings are coming up in April at Blowing Rock and in July at Lake Lure.

We talked about who goes first putting in their utility lines power or gas? We were told that in Durham we like to have power in first before gas but there are some cases a developer gives the go ahead for gas to be run.

We had a drawing for some prizes.

We talked about having locate tickets called in “adjoining addresses” how many does that consist of and I think it was said that 5.

When someone calls in an address and says locate from ex. 102 Free St to the temporary are “All” the addresses to that point covered? Really in this case you should have more specific direction by white lining or flag or stake.

We should not be calling in locates saying right or left but using north, south , east, or west.

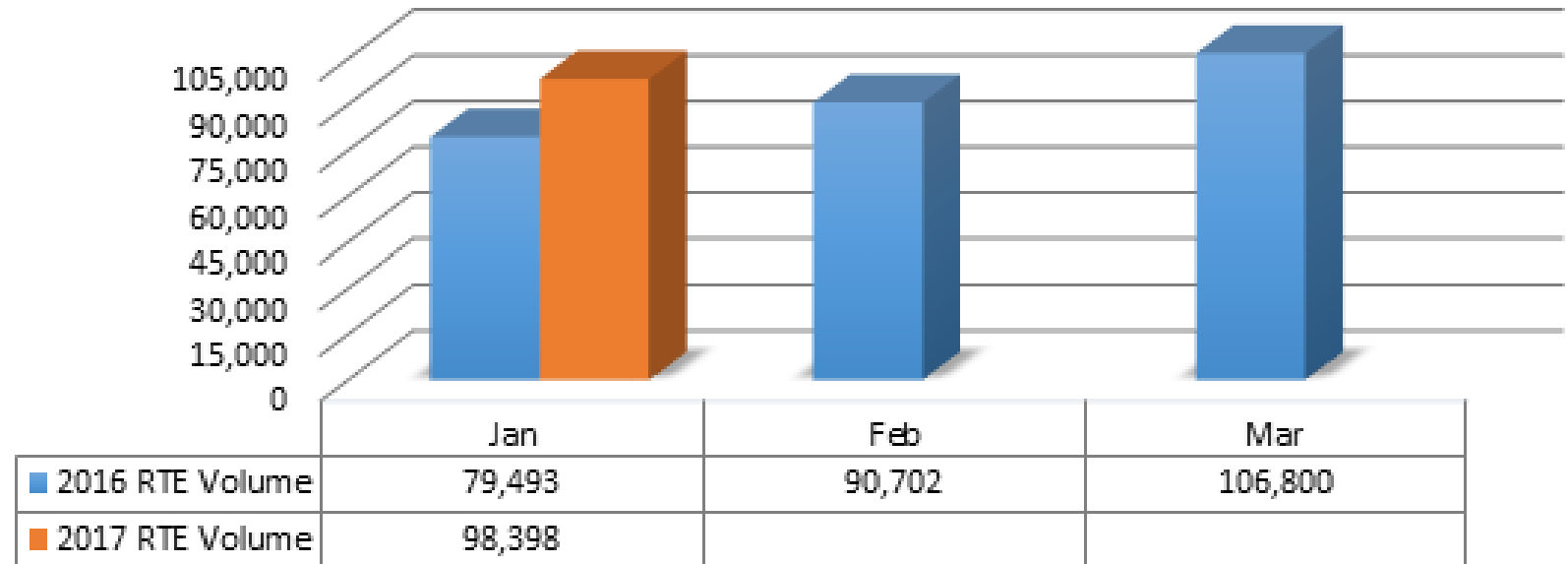

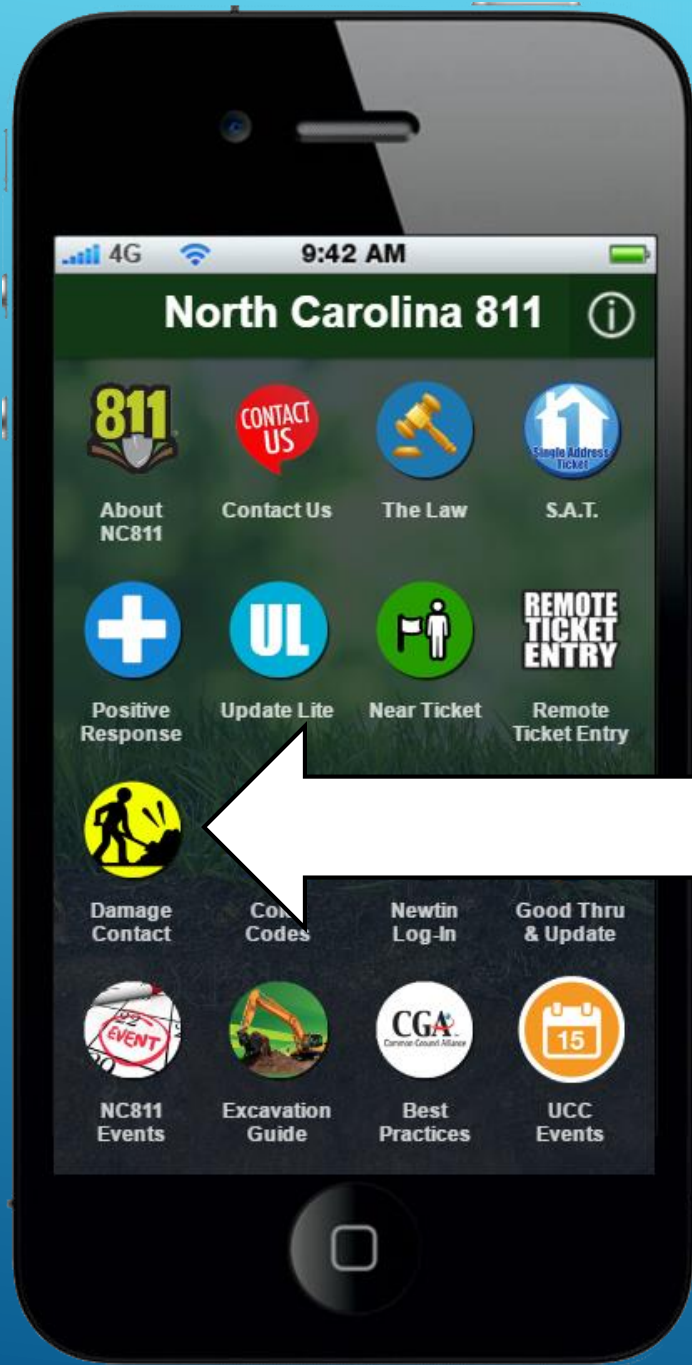
