Meeting Topics Discussed:

- The NCUCC is celebrating its 75th Anniversary. Playing cards and T-Shirts will be available in April 2017. We now have 48 UCC's.
- Locate Requests for February 2017 totaled 147,102 requests. This was an increase of 5.7% from last year at this time. Transmission Totals for February totaled 822,463 transmissions. This was an increase of 10.9% from last year.
- County Ticket Volume: Total tickets for Guilford County totaled 7,562 tickets. This was an increase of 10.7 % from last year. Average locates per day equals 379 locates. YTD total tickets for Guilford County totaled 15,148 tickets. This was an increase of 15.2% from last year.
- County Ticket Distribution: Guilford County had 7,562 requests. This was followed by Greensboro with 4960 requests and High Point with 1095 requests.
- Remote Ticket Entry: The excavator must specify the type of the proposed evacuation when creating a New dig ticket.
- April is National Safe Digging Month. Go to their website to get a toolkit to help promote safe digging and to educate homeowners. There are five steps to safe digging.
- Best Practices: New link on their app. There are over 130 "best practices" to increase safety and prevent damages to underground facilities. There practices must be 100 percent in agreement.
- 2017 NC811 Fire Station Marquee Challenge: Can order a free banner for your business. Chance to win \$1,000.00. Also two grills to be given away.
- NC Underground Damage Prevention Review Board: Board meets quarterly. Total of 54 cases have been reviewed. Some had fines recommended, some were missing critical information, and some were found "no violations." Next Meeting is scheduled for April 18, 2017 at 10:00 a.m., 2550 Operations Way, Raleigh, NC.
- Next holiday will be on April 4, 2017 (Good Friday).

NC Underground Damage Prevention Review Board Update

- Board meeting Quarterly
- 54 cases have been reviewed and letters have been sent
- Some quick stats:
 - Of 65 total complaints received, 54 have been reviewed by the Board
 - 33 were found to be violations
 - Of those 3 had fines recommended
 - 15 had either the wrong party identified or were missing critical information to make a determination
 - 6 were found to be not violations
