Projects:

SREMC – Subdivisions in Anderson Creek area, pole change outs in Johnston County.

PNG – In Harnett County – Angier gas line through town is finished, 8 inch on Hwy 401; in Johnston County – 2 DOT projects, traffic circle in Benson, move 4 inch in April on Covered Bridge Rd., 40/42 project, I95 widening in the future.

NCDOT – Hwy 42 project – phase 2 is done, Hwy 70 upgrade, bridge projects.

Discussion:

Parrish Reddick with NC811 presented the NC811 report. The presentation showed that overall locate tickets were up 10.5% from last year. Harnett County had a 1.1% decrease in locates and Johnston County had a 12.4% increase. Parrish reminded everyone of the law changes that went into effect on October 1, 2019 and said that the Operator Identity Codes on are on the Member Services page on the website and on the NC811 App. He showed a video recap of all the ways that NC811 has gotten the message out during 2019. The entire NC811 presentation will be attached to these minutes.
