SREMC – Subdivisions in Anderson Creek area, pole change outs in Johnston County.

NCDOT – Mark Edwards Rd. bridge replacement, utility relocation on Hwy 70, Hwy 42 project in Johnston County.

Discussion:

Parrish Reddick with NC811 reminded everyone of the UCC Monthly Damage and Project Report sheet that he has given out, you can get input from others at your organizations and have this filled out before coming to the meetings to provide a more accurate record of projects. The NC811 presentation showed that overall locate tickets were up 12.4% from last year. Harnett County had a .7% increase in locates and Johnston County had a 15.3% increase. 


