

SREMC – Subdivisions in Anderson Creek area, subdivision extension at Country Squire, Hwy 27 bridge project near Nursery Rd.

PNG – Subdivision in Clayton on Hwy 42, projects on Hwy 210 and Hwy 401 in Angier.

NCDOT – Hwy 42 project, Hwy 70 project to I42 starting at Buffalo Rd to Wilson Mills, bridge projects in Johnston County.

Duke – Feeder tie on Hwy 401 north of Lillington, Hwy 42 project from Glen Laurel Rd to Buffalo Rd, 7 span across I95 near Four Oaks.

Spectrum – Relocation project near Nursery Rd.

Discussion:

Parrish Reddick asked all for approval of last month's minutes, they were approved. He then presented a video about 811 Day and a video on School Bus Safety. The NC811 presentation showed that overall locate tickets were up 13.2% from last year. Harnett County had a .4% decrease in locates and Johnston County had a 14.6% increase. The Safety Moment video reminded all to stay at least 10 feet away from all lines, call 811 before digging and check out the new OSHA rules. Parrish spoke about Severe Weather Preparedness and gave us a checklist of things we should have ready. He also went over important dates that are coming up, all of these and the rest of the NC811 presentation are attached to these minutes. Parrish went on to let everyone know that the NC811 app has information on the new law versus the old law. He also pointed out that the reason we meet is: for communication, to prevent damages, to promote white lining and to create relationships with locators. Parrish stressed that the more specific you are on the locate tickets, the more accurately it will be located.

With the increase in 3 hour tickets, the question was asked what the point of the 3 day ticket is if we have to continually call in a 3 hour ticket afterwards. Hopefully the issues that have caused the increase in needing to call in a 3 hour ticket will improve and this won't be such a big issue.

Todd with Lee Electrical encouraged everyone to invite Parrish with NC811 to our companies to educate our employees on NC811, locates and the purpose of it all.

Andrew reminded everyone that communication is key in getting lines located and he adjourned the meeting.
