



NC 811 / One Call presentation was given by: Brian Morehouse- info every one of the new laws and procedures that are in place since October 1st 2019.
 Go over all changes. Be sure when calling in tickets to remember the Holidays that will be observed, those days will not be part of the (3) day call in for tickets to clear.

Brian Morehouse asked the group to please handout their business cards to those in attendance. Trying to get a networking process together.

Talked to the group about inviting others to our local UCC meeting to help us grow in attendance and get the word at to all about the importance of being a part of this UCC.

Reports

- A. NC 811 / One Call Brian provided us with the monthly 811 update. Also Brian talked to us about 811 having 811 come to your office and do an 811 Safety Presentation. Brian Morehouse went over the November 2019 presentation giving the totals for YTD and Monthly number for Tickets called in, average locates per day and (3) hour tickets. (This is included as a PDF on the UCC website) Brian went over the safety procedures in cooking a turkey and how to be safe during the holidays. NC811 discussed ticket issues, new law changes and procedures. Went over with everyone what an Emergency was, how to call in a Emergency, how these tickets are being accepted through the computer at this time along with (3) hour Locate Tickets. It is told what can happen when you call in an Emergency Ticket and it is not declared an Emergency. Class 3 Misdemeanor, and a fine up to \$ 250.00 can be issued. Went over the UGDPRB, new location and how this process works. Told the group that you can now put complaints in online. Ask everyone to please download the NC 811 App. Went over how to do this and how to update this APP. Michelle Flowers with the NCUC did a small presentation on the stats of damages for North Carolina.
- B. N.C.D.O.T Money has been cut out of the budgets and things are on hold with many projects. Work continues within the area but many projects have been put on hold. The I-26 moves forward and is a very big project within the area.

- D. Duke Energy NA
- E. City of Hendersonville-No Major Damages to report. General Maintenance on lines continues. Have had a number of Emergency situations with water line breaks and crews having to work extended time over the nights and weekends. Locates are up and having issues with a few contractors performing work for Duke Energy hitting lines and not giving very good direction on what is needed to be located. They report that they are going out on site and being told that projects are being started on a certain date and having to update tickets numerous times with no sign of work within the area
- F. **Oaks Homeowners Association**-Same report as last month. New road work will be done in this subdivision with over 110 homes and 7 outbuildings throughout.
- G. **Dominion Energy**-Locate tickets are up for 2019. Reported that Mastec has done a review of tickets within he area that they do for Dominion Energy and are looking at ways to cut those tickets down and not to reported updates on a continuous basis.
- H. NCUC- Nothing to report at this time- gave presentation of damages within the area
- I. NCDOT Contractor- Reports of not getting locates marked on time and having issues with them coming out on (3) hour tickets. Reported of one issue that they had a problem getting lines marked when it is known that there are facilities within the area of excavation. This held their project up and delayed the progress of their work.
