Meeting began at 12:05 pm

Chairman Ralph Murphy welcomed everyone to our new venue at the Onslow Water and Sewer Authority (ONWASA) main office. He asked that everyone please sign in and silence their cell phones.

ONWASA Safety Officer Greg Oliver gave a brief overview of facility safety reminders.

American Red Cross representative Kristin Willis was the speaker for the month of February. She discussed how the Jones/Onslow area has a critical need for blood and blood products, especially after the wintry weather we have experienced in our area recently. She asked that if any companies were interested in holding a blood drive, to please contact her for more information.

NC 811 Education Liaison Howard Corey reviewed the difference between a 3-hour ticket and an emergency ticket and also the need for white lining areas where excavation is to take place. Howard also discussed why a 3-hour ticket should not be used in the place of a destroyed marks ticket.

Looking at the numbers...

- Tickets and Transmissions in NC for January 2018 increased over 3% from January 2017.
- Jones County Ticket Volume in 2017 was 1,542 a 21% decrease from 2016.
 Onslow County Ticket Volume in 2017 was 22,311 an 18.4 % increase from 2016.
- For Jones County, the majority of locates were requested in the Pollocksville area. For Onslow County, the majority of locates were requested in the Jacksonville and Sneads Ferry areas.

LOCAL UTILITY UPDATES

Charter Communications – Jody with Charter said they've had 93 damages already YTD which is actually LOWER than this time last year. He discussed communication with others about calling in locates and educating the contractors; making sure everyone knows the process.

Piedmont Natural Gas – Will start a project at the beginning of March installing 2950 ft. of 4" line on Hwy 53 to Hwy 258 by Baker's Restaurant. They will also be installing a 2" main at the new courthouse downtown. They are in the planning stages of installing a new line on Piney Green from Hwy 17 to Hwy 24. (Ugghhh!)

NCDOT – Be on the lookout for several crews doing lots of ditching from now through June all over the county. They are also doing cross line replacement.

UUPLLC – Staying busy.

Sadale Utilities - Working over 5 counties right now; also in Swansboro and Hubert.

JOEMC – Covering 5 counties, busy in Sneads Ferry. Been busy working on projects at schools and many commercial projects. Still working on conversion pole replacements.

ONWASA – Jeff Hudson talked about how busy everyone is with construction and new builds. He also discussed the "Stop the Bleed" training which is offered free from the Naval Hospital.

Onslow County Fire Marshal Brian Kelly – He discussed that Onslow County EMS will be at the UCC meeting next month to share the "Stop the Bleed" program. March 31st will be a public fair where they will be set-up to share that program. It's expected to be an active wildfire season. Please clear as much of you can of grass and weeds around your utilities.

Jacksonville Mechanical/Sadale Utilities/R&W – Working at Cherry Point and Camp Lejeune.

Carolina Water - Repairs and maintenance at White Oaks Estate and Regal wood.

City of Jacksonville – Staying busy.

Town of Maysville – Been busy with the by-pass coming thru. They are now members of NC811.

PLURIS – Busy as usual; New construction in Sneads Ferry and North Topsail; Preparing for tourist season.

Century Link - Low on personnel right now; response time may be longer.

USIC – Business as usual. Staying busy.

Vice-Chairman Donnie Smith (JOEMC) reminds everyone to please watch out for kids in the streets, no matter what the age! Be aware of the kids loading/unloading the buses, including the older kids because they are often distracted. First, the concern will be shared with the chair of the local UCC for the county in which the problem is occurring. That gives them a chance to bring it up at the next UCC meeting. Secondly, the issue will post to a State UCC database for discussion at the next meeting. If a problem is happening in one area, it may also be part of a larger problem. This method allows all concerns to be shared with everyone so that a solution is more likely to be found.

Destroyed Marks & 3 Hour Tickets When to properly use each

Destroyed Marks Ticket BURIED SEWER BURIED WATER

DESTROYED MARKS

If locate marks have been destroyed, the excavator must contact NC811 to issue a Destroyed Marks ticket requesting a remark of the area from the original ticket. A Destroyed Marks ticket does not extend the life of ticket; it will expire the same day as the original locate request. A 3 Hour Ticket should not be used in case of destroyed marks.

3 HOUR TICKET

If an operator fails to respond to the positive response system, the excavator may proceed if there are no visible indications of a facility at the proposed excavation or demolition area, such as a pole, marker, pedestal, meter, or valve. However, if the excavator is aware of or observes indications of an unmarked facility at the proposed excavation or demolition area, the excavator shall not begin excavation or demolition until an additional call is made to the Notification Center detailing the facility and an arrangement is made for the facility to be marked by the operator within three hours from the time the additional call is received by the Notification Center. A 3 Hour Ticket should not be used in the case of destroyed marks.
