#### Looking at the numbers with Howard Corey (NC 811)

- For 2019 vs 2018, there was an overall 10% increase in locate tickets and transmissions.
- In 2019, Jones County had 1,641 locate requests, compared to 1,228 in 2018.
- Onslow County had 25,136 locate requests in 2019, compared to 20,739 in 2018.

#### \*\*LOCAL UTILITY UPDATES\*\*

<u>City of Jacksonville</u> – Locates for gas lines on Piney Green Rd; Fiber going down Gum Branch Rd, Hwy 258 and Hwy 17.

<u>Piedmont Natural Gas</u> — Lots of gas lines going in on Piney Green Rd and will probably be there 3 to 4 months. Next, will go to Drummer Kellum and Gum Branch Rd.

<u>Coastal Carolina Community College</u> – New class started in January teaching trenching, shoring, excavation and safety.

<u>Parker & Associates</u> — Staying busy with design work. Extending services to Carteret, Cedar Point. New project @ Koonce Fork Rd. Stateside project is ongoing. Reminder that utilities should be located before design work is done.

<u>USIC</u> – Busy with fiber projects, 5G cell phone service. If you get somewhere and need help with markings, just call. Never seen it this busy. Hiring locators.

<u>NCDOT</u> — Working with half of the normal budget. Hoping to get more funding in July with the new fiscal year. Doing mainly roadway emergencies. They will be re-paving Henderson starting Feb — March and should be finished by June. *Check out NCGO.com and GONC.com for maps and project information.* 

<u>CenturyLink</u> – Business as usual. Janet Laird is back working in this area.

<u>City of Maysville</u> – Not quite as busy since the bypass is done; but staying busy.

<u>PLURIS</u> – Small projects in Sneads Ferry; new housing development by Clay Hill Rd, running a line down Tar Landing Rd for new elementary school on Folkstone Rd in the next few months.

**<u>IOEMC</u>** – Staying very busy, working in Pender, Duplin, and Onslow. Several projects coming up, changing out more transmission poles; some commercial projects including the school on Folkstone Rd, service orders for new lines every day.

<u>Onslow Emergency Services</u> – Lots of construction and keeping up with inspections.

<u>ONWASA</u> – Busy with developmental projects. Several new subdivisions coming up. More aerial crossings coming, one on Hwy 17 - New Bern Hwy at the bridge, one on Ramsey Rd and one on Drummer Kellum Rd. On the Capital Project side, a new project is beginning at the wastewater plant off of Gum Branch Rd. It will not affect roadway traffic.

#### This meeting ended at 1:00 pm. There were 42 attendees.
