

### Utilities Coordinating Committee (UCC) Jones/Onslow Counties Monthly Meeting July 20, 2017

### **Meeting Minutes**

Chairman Ralph Murphy welcomed the committee and asked that everyone sign in and silence their cell phones.

### Updates from NC 811 Education Liaison, Howard Corey

Brian Kelley, Fire Marshal (Onslow County Emergency Services) was an honorable mention in the fire station marquee challenge for the month of April. Congratulations to Brian and his staff!

### Looking at the numbers...

- Total Locate Ticket Requests in NC for June was 170,404 a 2.9% decrease from June 2016. Total Transmissions in NC for June were 971,633 – a 2.3% increase from June 2016.
- Onslow County had 2,316 locate requests for June a 34.6% increase over June 2016; while Jones County had 173 requests for June – 30.8% decrease from June 2016. This averages out to 113 tickets per day.
- For Jones County, the majority of locates were requested in the Pollocksville and Trenton areas. For Onslow County, the majority of locates were requested in the Jacksonville and Sneads Ferry areas.

Howard showed a brief video to remind everyone of the dangers of working in the heat and how important it is to be hydrated. Remember that you have to drink your water AHEAD OF TIME – before being out in the heat, so that you are properly hydrated.

Rachel Goslee with United Rental gave a presentation on Trench Safety. She taught UCC members the importance of having a trench box; also about sloping, the various soils, and dangers of trenching near a road. Rachel also showed pictures of what can happen if you are digging without protection, not using a trench box, and just not being safe.

### Other Topics of Discussion...

Chairman Murphy discussed recent locate request issues. He stressed the importance of giving the actual physical address of where the work will be performed; no mailing addresses.

Remember...you must call in a damage report to NC 811 if you damage someone's utilities. It helps to have a record of the damage, **and IT IS THE LAW**.

Ralph announced that there is still no lunch sponsor for the months of August and September. If no one volunteers, committee members will need to bring their own lunch for those meetings.

Ralph also mentioned that it's time to start preparing for the Annual UCC Breakfast meeting to be held October 19, at 6:30 am, at the Jones/Onslow EMC warehouse. Please get with your company to decide on what you are able and willing to donate, whether it is money for food/drink/supplies, door prizes, small items for the goody bags, or time helping to prepare, cook, set up, or clean up. We appreciate everyone's participation in making this year's breakfast meeting another successful event!

### \*\*LOCAL UTILITY UPDATES\*\*

**United Rental –** Staying busy in Wilmington area, many new developments.

**Onslow Emergency Services** – Discussed their smoke alarm program and asked for volunteers for help to install those smoke alarms. Please contact Fire Marshal Brian Kelley for more information.

**JOEMC** – Ticket volume is up; a lot of work in Jacksonville and Sneads Ferry. Extremely busy.

Vice-Chairman Donnie Smith discussed an issue with a dump truck that got into electrical lines. The responsible party did not call in the damage; other people called it in. PLEASE be careful around power lines when using your trucks and equipment. Always use a spotter. If a live line is hit, call 911. Also, Jones/Onslow EMC has a 24 hour dispatch you can call to report downed power lines. Always stay on the scene and wait for help to arrive.

**PLURIS** – Working at Oyster Landing, Bridgeport, Dixon Middle School, Permeta Branch, Tidewater.

**NC DOT –** Just finished crosslines on Cavanaughtown Rd, White Oak River Rd, and High Hill Rd, and paving throughout the county; will be working on Queens Creek Rd in two weeks. Ralph discussed issues concerning NC DOT contractor (Stay Alert) for installing signs along Hwy 258 without a locate request. He says that is not the first violation from that contractor.

**UUPLLC** – Staying busy; having trouble finding help with good work ethic.

**ONWASA** – Sewer Improvements project starting soon in Holly Ridge on Hines St and Jenkins St; project will last about 6 months

**Piedmont Natural Gas** – Scattered services on the base; Having land issues with moving the lines at the main gate of Camp Lejeune. Having problems with some contractor crews installing cable for Onslow County Schools.

**USIC –** Staying busy. Call if you need help.

**Century Link** – Staying busy; Over 100 trouble calls daily, many from Hwy 53 and many times, fiber is being damaged even when a locate has been done.

Lambert Cable – Staying busy.

Please make sure to clean up behind yourselves after the meeting. Whichever member sponsors the lunch must remove the food/drink items from the premises.

Second, the issue will post to a State UCC database for discussion at the next meeting. Hey, if a problem is happening in one area, it may also be part of a larger problem. This method allows all concerns to be shared with everyone so that a solution is more likely to be found.


