Meeting began at 11:45 pm

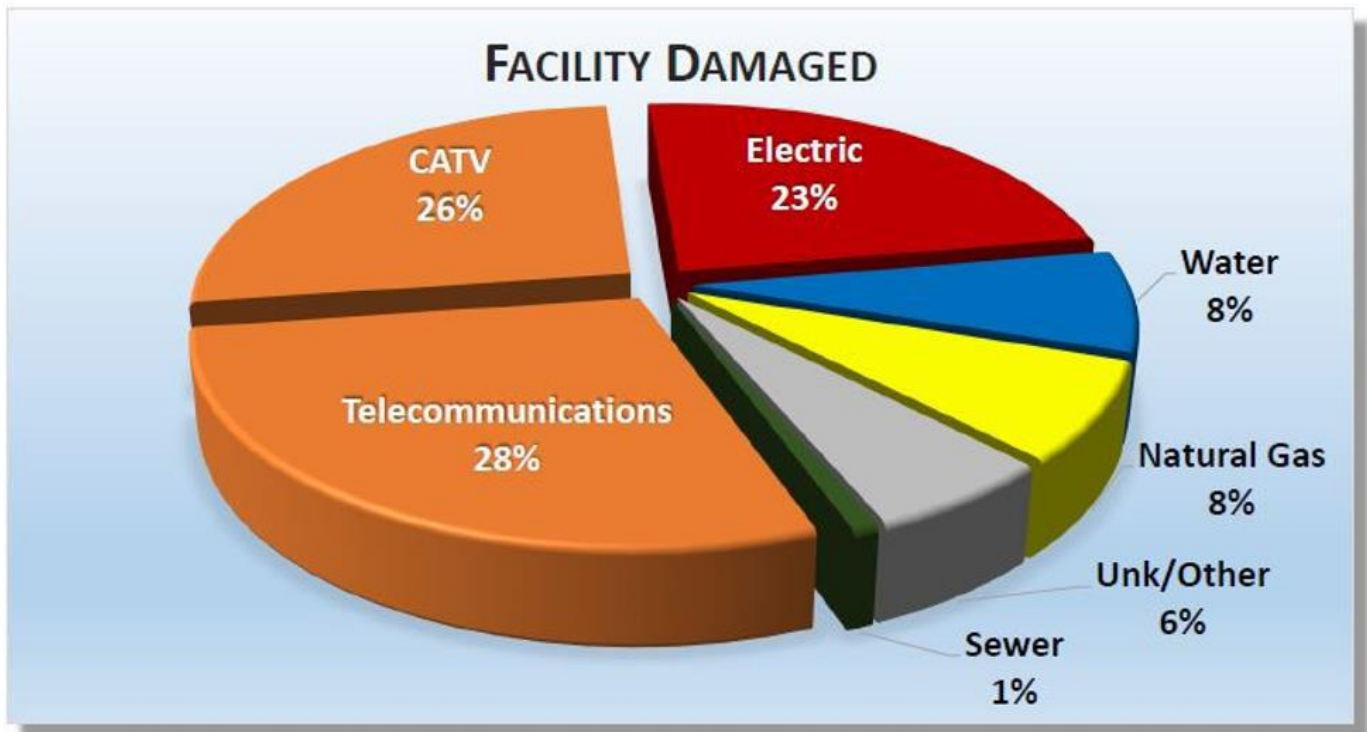
Chairman Ralph Murphy welcomed everyone and asked that they please sign in and silence their cell phones. He also welcomed all the newcomers to our UCC Meeting and thanked Nick Brown with Spectrum for providing lunch for today’s meeting.

ONWASA Safety Officer Greg Oliver gave an informative presentation on local traffic issues. He reviewed the reasons why we have so many traffic incidents in our area and suggested ways to improve those statistics.

Looking at the numbers...

- For **April 2019** vs **April 2018**, there was an overall **15.8%** increase in locate tickets.
- Transmissions increased by over **13%** compared to **April 2018**.
- **Jones County** had **169** locate requests for **April 2019** with an average of **8** tickets per day. That is a **72% increase** over **April 2018**.
- **Onslow County** had **2,161** locate requests for **April 2019**, with an average of **103** tickets per day. That is a **13% increase** over **April 2018**.
- For **Jones County in April 2019**, the majority of locates were requested in the **Maysville** and **Trenton** areas. For **Onslow County in April 2019**, the majority of locates were requested in the **Jacksonville** and **Sneads Ferry** areas.

A lengthy discussion was held concerning numerous issues involving locates not being performed. Chairman Ralph Murphy asked those parties interested to continue the discussion after the UCC Meeting, and he promised to help in any way possible.

****LOCAL UTILITY UPDATES****

NC DOT – Busy all over; Foy Lockamy Rd, Hwy 172 and Gum Branch Rd projects are starting up. DOT says Hurricane Florence cost NC DOT \$350 Million Dollars in repairs; \$50 Million of that for Onslow County. They also say that in the future, when there is a mandatory evacuation issued, they suggest you leave the area because their staff and equipment will be moved out of harm's way.

UniTech – (Locating service for CenturyLink) – Supervisor, Maurice, says he is doing his best to handle locate requests.

Piedmont Natural Gas – Very Busy; 25 crews working in and around Onslow County.

Spectrum – Running lots of fiber to new homes.

Mid Atlantic – Busy, many new subdivisions, running fiber to many commercial projects coming soon.

USIC – Volume is up; Staying busy. Spirit Communications running several miles of fiber in Onslow County, including on Camp LeJeune.

Onslow County Fire Marshal, Brian Kelly - Everyone should be doing hurricane preparations now. Onslow County had over 8 million pounds of storm debris hauled away from Hurricane Florence. He asks that everyone have a hurricane plan in place. BE PREPARED! Know your role. Brian says to expect a category 4 or 5 to come because history repeats itself. When the weather says a hurricane is a category 1 thru 5, that refers to WIND SPEED only, not rain or storm surge. Hurricane Florence had the rain of a Category 5 storm and the storm surge of a Category 4. DO NOT underestimate hurricanes. Also, wildfire season is still in process. Brian asks that everyone keep the grass and weeds cut around your utilities and right-of-way at all times!

JOEMC – Very busy; Working in many new subdivisions. ASKS THAT YOU PLEASE MARK CLEARLY AROUND YOUR UTILITIES.

Jacksonville Mechanical, R&W, Sadale Utilities – Busy; handling repairs in various locations; working on Camp Lejeune and Cherry Point.

PLURIS – Doing maintenance, preparing for tourists at Sneads Ferry/Topsail; working with DOT project on Hwy 172.

Donnie Smith – Safety Instructor at Coastal Carolina Community College – Spoke about performing pre-trip inspections on vehicles.

City of Jacksonville – Have been in recovery mode since Hurricane Florence. Many new projects coming over the next few years.

ONWASA – Raw water transmission line project down Hwy 17 in Holly Ridge to Hwy 50 wells. Directional drilling project to replace aerial crossings at High Hill and Verona Rd.

This meeting ended at 1:00 pm. There were 32 attendees.

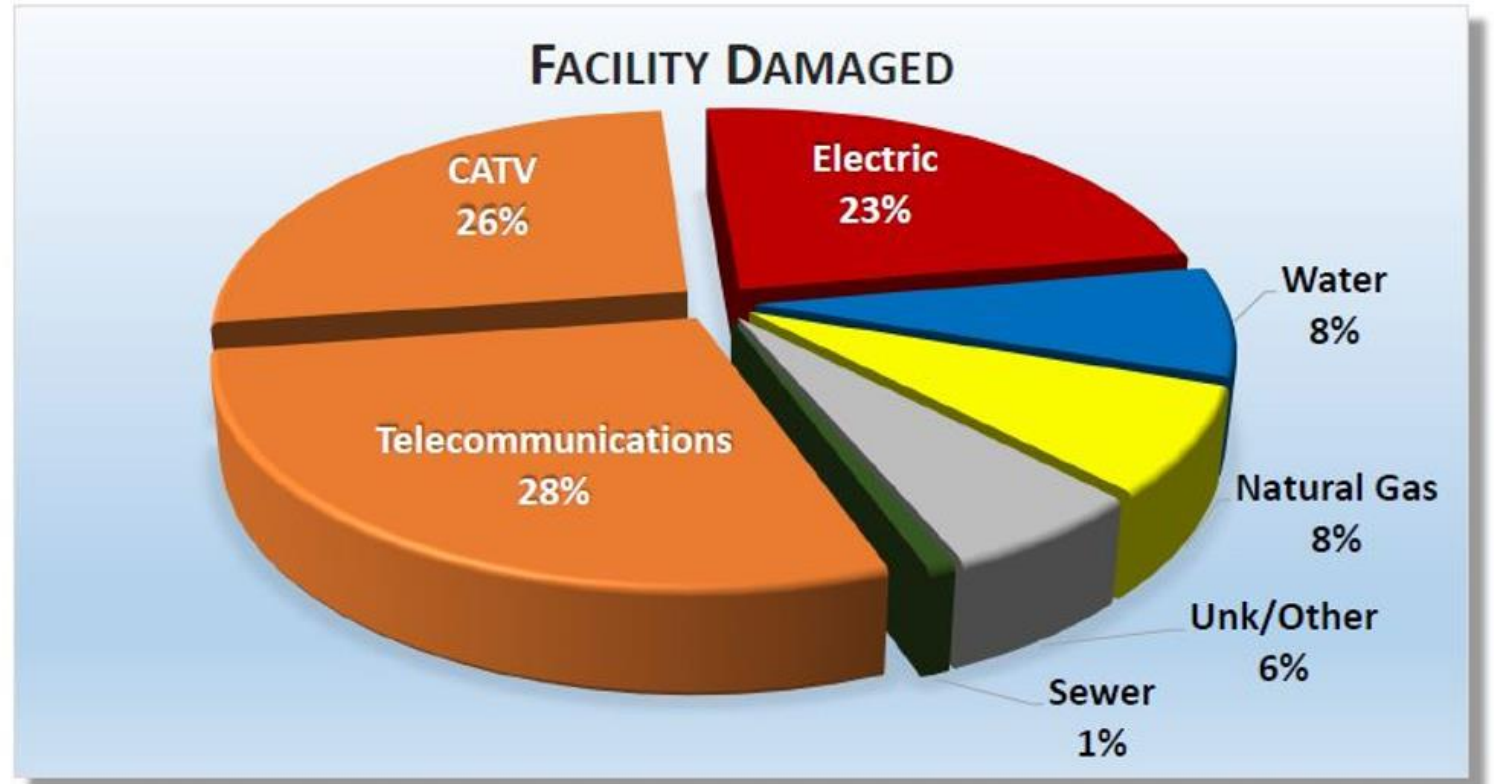

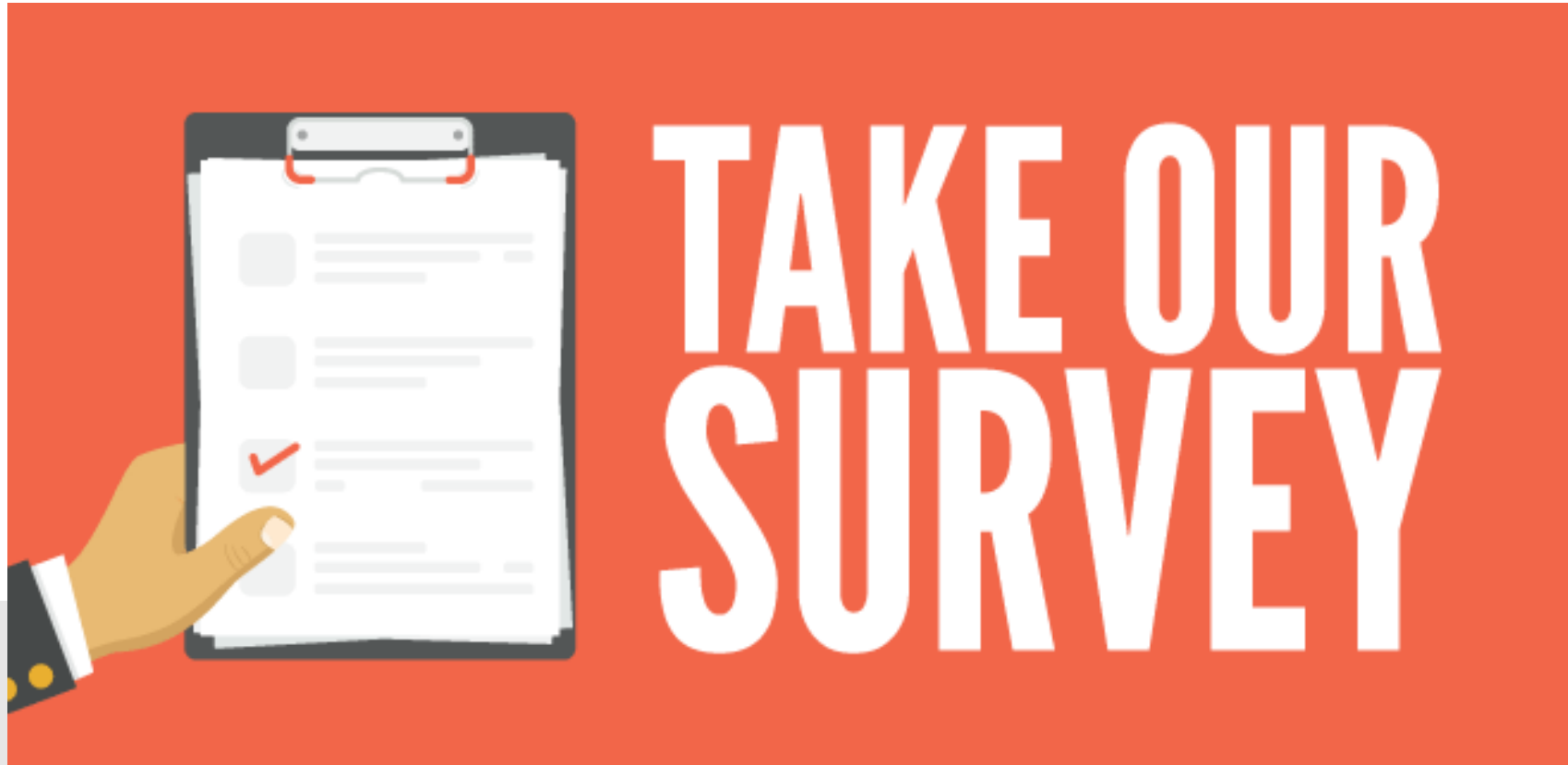

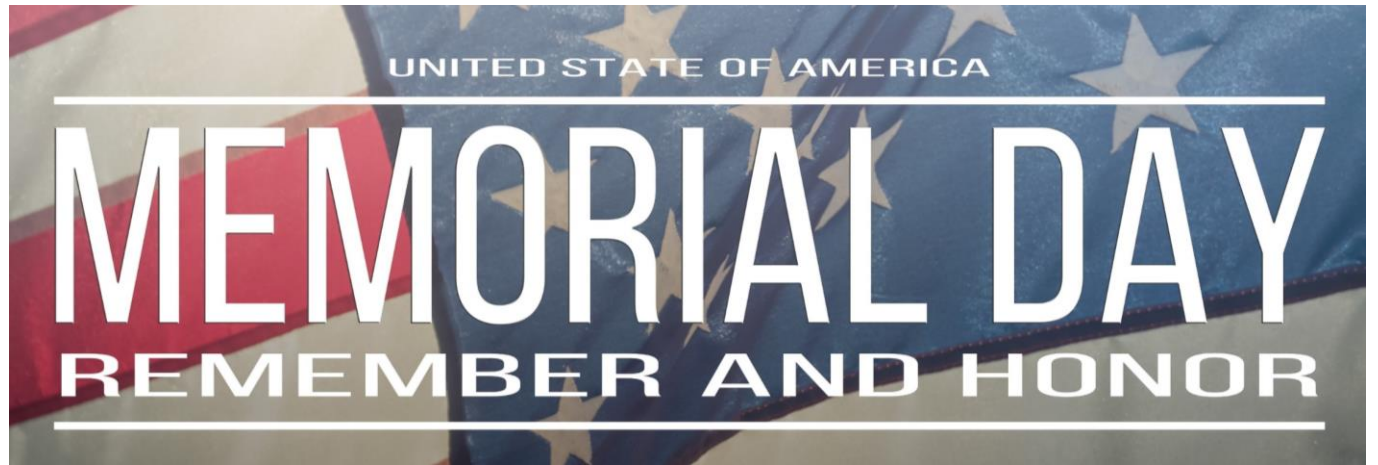
