- Safety Moment: Warren Co had a severe blockage on a sewer main near US 1
 HWY, everyone worked together and it went smooth with all utilities involved.
 It's very important for us to have our UCC meetings to build relationships.
- o Vance Construction thanked PSNC for their prompt response to a hit gas line
- City of Oxford will have an ongoing water and sewer line project that will take place in existing neighborhoods and in town. Locate tickets may double and they may be calling in for assistance. Utilities that were present are all willing to help as needed.
 - o DOT will be paving their roads in Oxford in March 2019 so those roads will be worked first and not in 1 place, they will be spread all over.
 - Spectrum can possibly have someone meet with crews to discuss the dos and don'ts.
- Design survey requests are designed to help with these designs and utilities have 10 days to respond.

- Safety Moment: 12/28 Construction employee was killed when pipe slid off backhoe.
 - o Crew cut gas line w/ saw, very close call. Valuable lesson learned.
- City of Oxford has approx. 20 miles of water and sewer lines to be installed. They are asking for assistance from all utilities before the process of them digging. Maps are available. 12" water line to begin in the next 30-45 days
 - o DOT will be paving their roads in Oxford in March 2019 so those roads will be worked first and not in 1 place, they will be spread all over.
- o By law locators have 3 days to locate an emergency locate ticket. It is important to build relationships with other locators and utilities to help with this process.
