




#### Locator Safety Awareness Week April 22 – April 27

#### Lee County UCC Meeting 879 N. Horner Blvd., Sanford, NC

<u>Meeting Time:</u> The meeting was called to order by the chairperson, Michael Lamping at 8:35 a.m. Introductions were made.

**Total Members Present:** There were Sixteen members.

**Recent Damages:** There were no significant damages that this group were aware, within Lee County, since our last meeting. Mike Lamping, did state that they have incurred some recent small damages.

#### **New Business and Projects:**

Michael Lamping, with the city of Sanford, stated that city is continuing to grow with some new commercial development. Michael stated that there is a new restaurant by the name of Valentes, that will be built on main street. There is also a new single family home subdivision that will be started in a couple months, to be constructed near Clearwater street in Sanford. Lee Parris, with NCDOT, stated they are working on a road widening project at thirty-eight and Broadway. He also stated that the subdivision of Nottingham will soon be developing phase five of this development. There is also a new bridge on 15 and 501.

#### **NC811 Presentation:**

Kevin Smith gave the NC811 presentation. Kevin stated contractors can assist in the efficiency of the locate request by doing the following. \*Wait until the 11<sup>th</sup> or 12 th day to update a locate ticket. \*Contractors should be white lining the area they are going to excavate. \*Make certain white lining matches the locate request. (do not state locate entire property if area is indeed located) \*Only request locate tickets for the area in which you will be working in the next 3-5 days. \*Utilize Design Survey Tickets when possible. \*Contractors, reach out to your area locators and with good communication, let them know where you are actually working for the week.

#### **General Discussion:**

General conversation about the amount of locate tickets being requested and the inability of locators to fulfill the requests. Concerns with the group as to what the answer is in actually a long term solution for this scenario.

Meeting concluded after the general discussion. (above)
