Topic for the month: Locators should have training. According to the NC811 book 2016 edition, page 51states: 87-123. Training. (a) Every person who is an excavator, locator, or operator under this Article by virtue of engaging in these activities in the course of a business or trade has a duty to provide education and training to employees and to document such education and training. The training shall include sufficient information, guidance, and supervision such that employees can competently and safely operate the equipment used in the course of the business or trade and complete assigned tasks in a competent and safe manner while minimizing the potential for damage.

Staking University is one organization that offers locator training. They offer Locator Certification Seminars, On-Site training, Train the Trainer, and Online Training. BCPUA is going to contact a locator training facility and see if they can get someone to train a group of local locators. Once an agenda is determined, they will get with NC 811 and open it up to other companies to see if they will be willing to send their employees for training. Result is to have a large group of locators in our local area to be trained and certified.

Discussions

New Chairperson – Norman Bardon with Piedmont Natural Gas Secretary position is still available

NCDOT introduced their 2 new employees who will be learning the trade of encroachments for New Hanover and Brunswick Counties. They are Randy Chavis and Patrick Wurzel.

Piedmont Natural Gas has a new pilot program that will introduce coiled 4-inch plastic pipe into the system. The demonstration along Mohican Trail going to the new subdivision, Whiskey Branch, will be within 2-3 weeks. Notice will be sent out to UCC members if interested.

PNG has projects on Randall Pkwy going to the new brewery and projects in Brunswick Forest.

DOT – Hwy 211 project in Southport is tentatively scheduled to start construction June. All utility companies involved will be working together to get the first phase done by tentatively February 2019 before they can start phase 2 of the project. Phase 1 of Hwy 211 is from Midway Rd to St James. Phase 2 is from St James to Southport/ Robert Ruark Rd area.

DOT request that if a lane closure is required (5 feet or less from the edge of pavement) and the traffic is heavy, for safety reasons, a lane closure may need required if the work area is 10 feet from edge of pavement.

CFPUA has a valve project that will be replacing old valves within numerous areas of Wilmington. This valve replacement project will last up to 18 months.

Duke Energy will be going to a 3rd party investigator for their damages. PRG will be on site for all Duke Energy damages starting in June.

Howard Corey will be available to attend safety meetings, pass out Color Code cards, brochures and pamphlets. Get with him to schedule.

Wendy gave a tour of the Fire House after the meeting to those who were interested.






