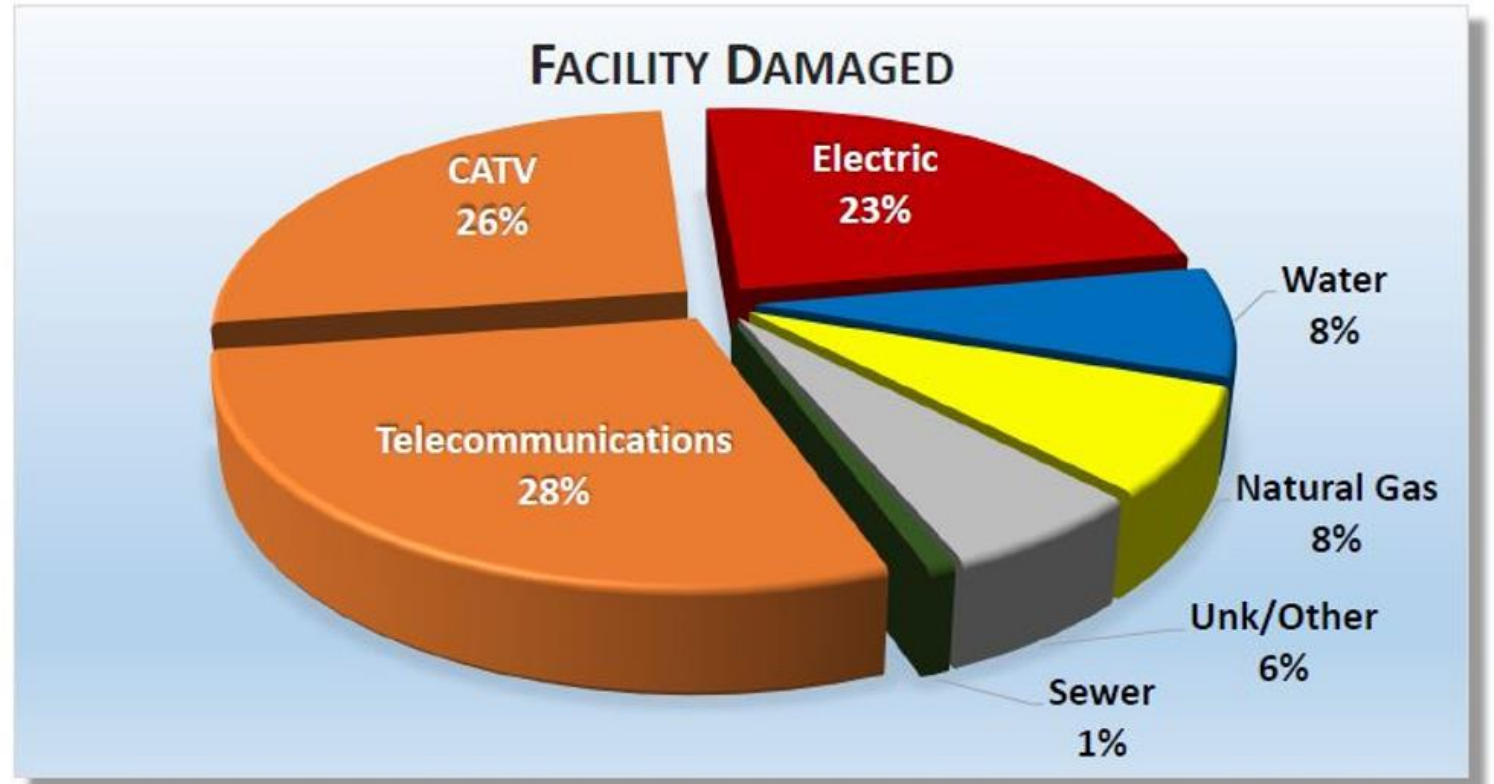

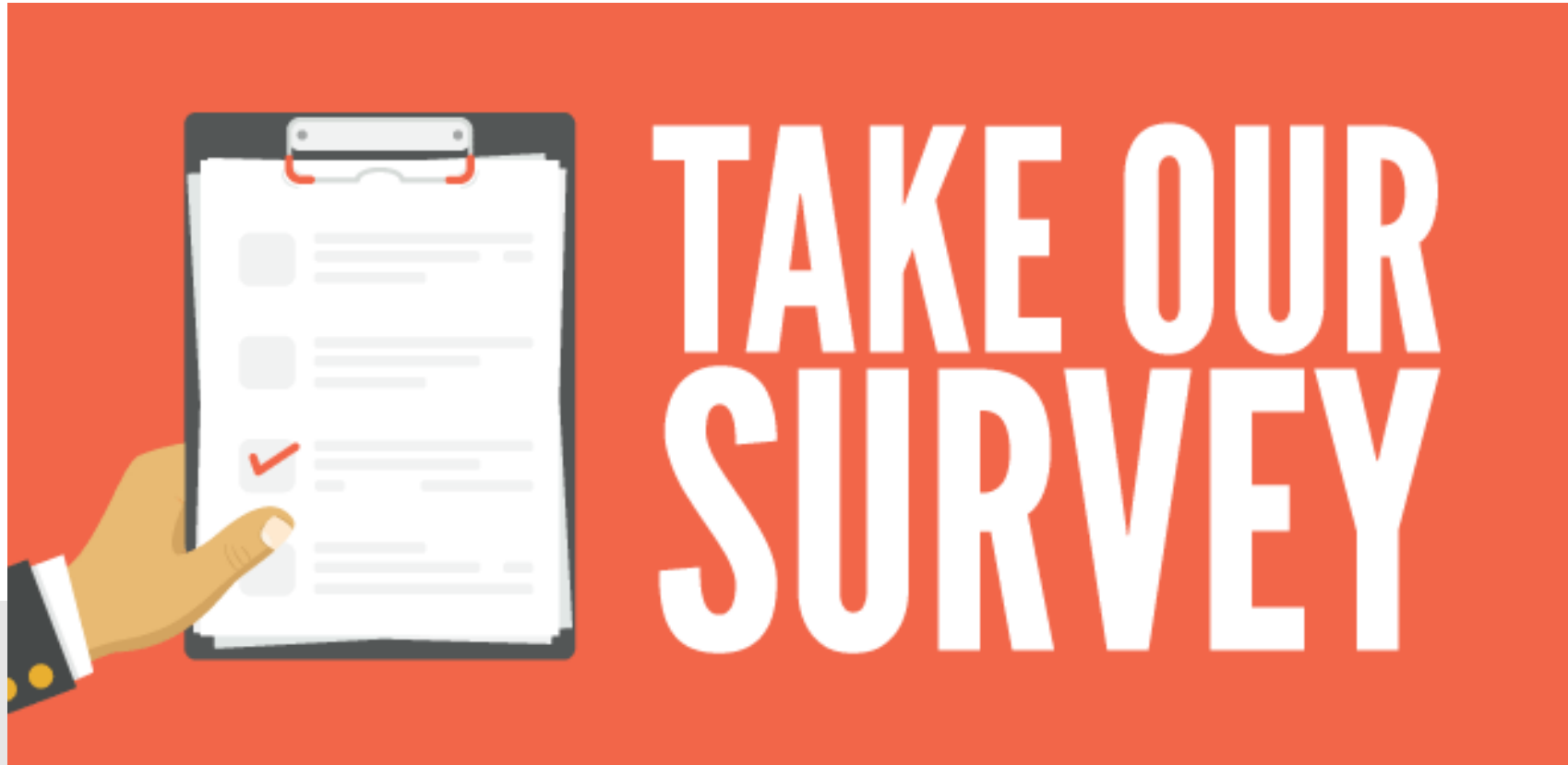

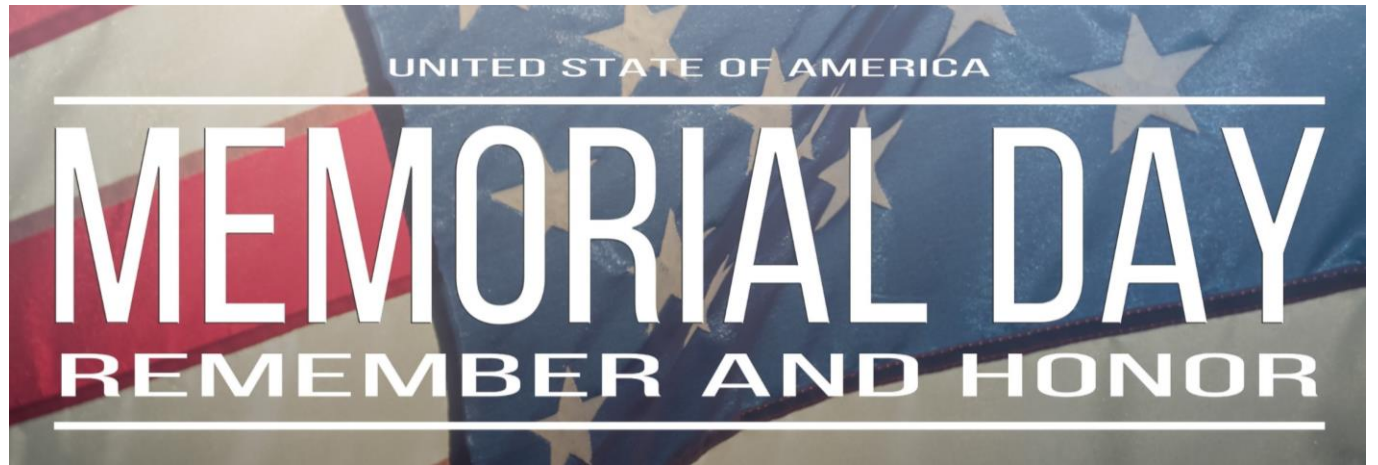

Half of All Damages Occur in Summer

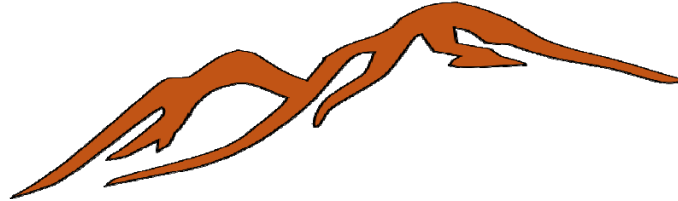
50 percent of reported damages occurred between June and September in 2017.
