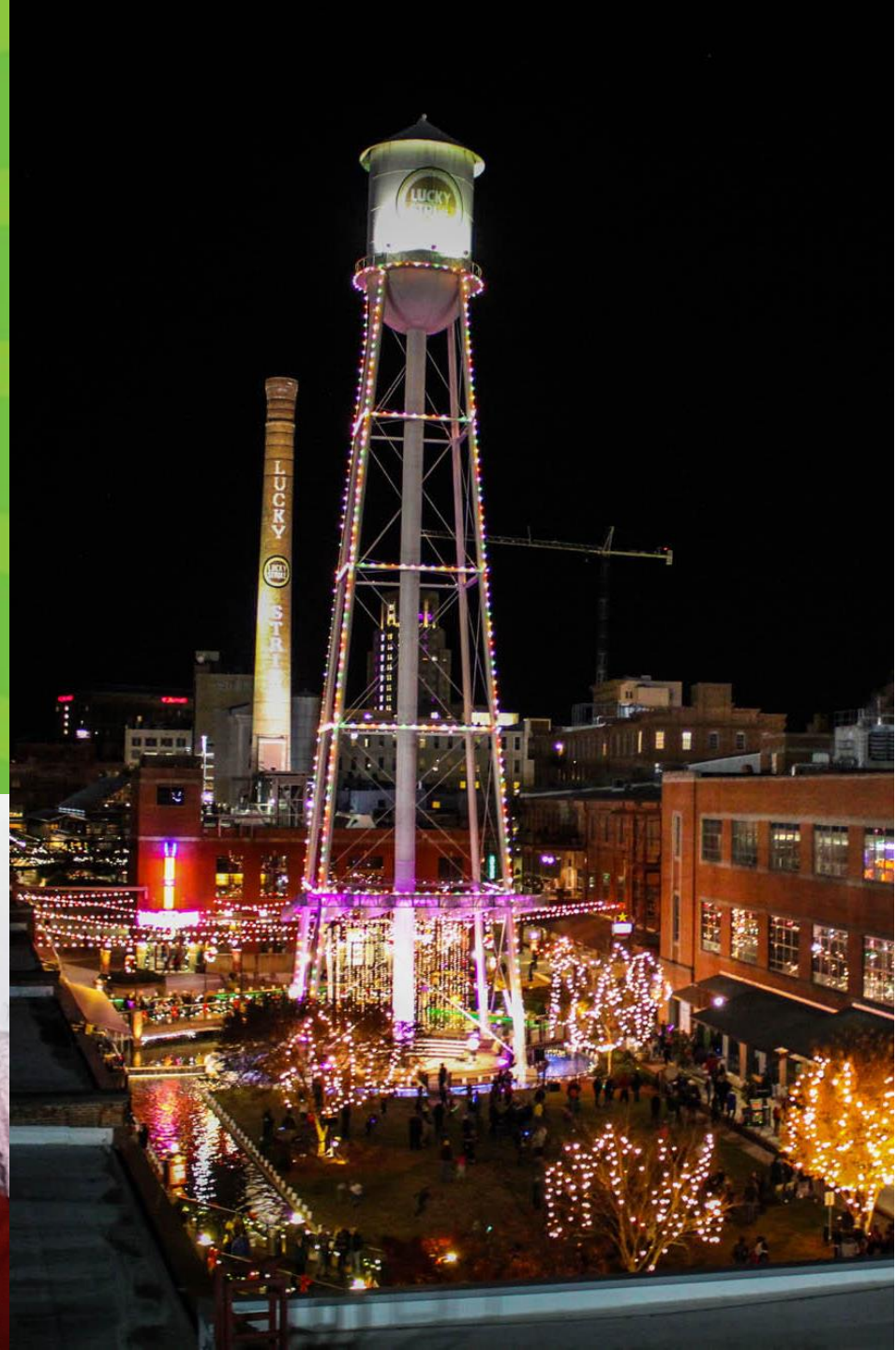

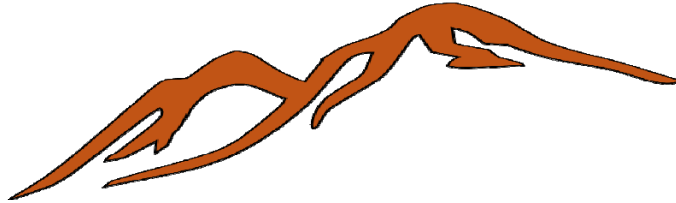

New Business

- NC 811 / One Call presentation was given by: Brian Morehouse- info every one of the new laws and procedures that are in place since October 1st 2019. Go over all changes. Be sure when calling in tickets to remember the Holidays that will be observed, those days will not be part of the (3) day call in for tickets to clear.

Open Discussion Looking at ways to increase the attendance. Spoke to everyone in attendance about having 811 come to their facility and do an 811 Safety Presentation for their employees and contractors.

Discussed issues with getting locates marked on time and having to call in multiply (3) hour notices.

Reports

- A. **NC 811 / One Call** – Brian provided us with the monthly 811 update. Also Brian talked to us about 811 having 811 come to your office and do an 811 Safety Presentation. Brian Morehouse went over the November 2019 presentation giving the totals for YTD and Monthly number for Tickets called in, average locates per day and (3) hour tickets. (This is included as a PDF on the UCC website). Encourage all of those in attendance to help others during the Holiday season. NC811 went over some of the new laws and procedures that are now in effect as of October 1st 2019. Brian Morehouse went over the 1,320 ft./1/4-mile rule, or how a ticket, single address can be called on one ticket. How to call emergency ticket in or use the online system. (3) Hour tickets also. Went over issues within the area with locates and contractor problems. Discussed with group about be safe on the roads with all the deer out at night, be aware and know what is around you.
- B. **N.C.D.O.T** – NA
- C. **Dominion Energy** – 26-mile line being installed in moving along well with expectations that the project maybe completed in late February 2020. General Maintenance work continues in the area. Locates have fallen over the last (6) weeks.
- D. **USIC** – **Was not at meeting but with an earlier conversation that are at full staff.**
- E. **Duke Energy** – NA
- F. **Frontier** –NA- Received a new contact for them in this area to be able to reach out if we have any problems or issues that need to be handled.
- G. **Rutherford EMC-** Reconducting 3 phase line that is moving along well. Substation work continues with upgrades with no issue. No new subdivision work within the area. Locates are going well, reported having issues with Bigham Cable, getting good information on locates that need to be done. Locator has reported that they have reached out to them. They are using Google maps which aren't current.
