






Remote Ticket Entry



Meeting Time: The meeting was called to order by Brian Morehouse with NC811 at 10:07 a.m.

Total Members Present: There were Eight members.

Recent Damages: There were no significant damages that this group were aware, within these four Counties, since our last meeting.

NC811 Presentation:

Prior to the meeting, Brian, conducted a safety checklist and went over where everyone will meet in case of a fire. He made note where the AED was and then assigned individual tasks, such as whom will call 911, who can perform CPR.

Brian then gave the NC811 presentation. Brian emphasized the importance of not driving while being distracted and for contractors to download the safe digging toolkit on NC811 website. Brian stated contractors can assist in the efficiency of the *Contractors, reach out to your area locators and with good communication, let them know where you are actually working for the week. Brian also gave special emphasis on putting down your cell phone and not operating a vehicle while distracted.

Brian asked all attendees to reach out to their co-workers and have them slow down near worksites and when a locator is seen along the roadside working. He gave attention to the job characteristics of being a locator and the various risks they face on a daily basis.

General Discussion:

Brian, asked for members to go around the room and discuss new projects, issues, etc. Greg Stevens with NCDOT, stated the state is experiencing some difficulty in having utilities relocated prior to crews arriving on a jobsite. Greg stated the utility companies are notified months in advance of an upcoming project. He stressed the importance of having more contractors attend UCC meetings to improve communication. Adam Novak, with division nine at NCDOT, stated that he agreed that communication is vital to the success of all projects and has found he is better informed by attending UCC meetings. Ray Sheppard with USIC stated new utilities are being put in the ground every day and unfortunately the prints do not always update in a timely fashion. Ray shared the importance of good communication from contractors to locators and have an open dialogue. He stated this promotes a safer working environment for everyone. Greg with NCDOT, also mentioned that he encourages all NCDOT offices to participate in their local UCC meetings.

General conversation about the amount of locate tickets being requested and the inability of locators to fulfill the requests. Concerns with the group as to what the answer is in actually a long term solution for this scenario.
