

#### **December 13, 2018**

Robeson County UCC Meeting Lumberton Public Works 215 S. Cedar Street Lumberton, NC

Meeting Time: The meeting was called to order by Douglas Ward at 9:05 a.m. Douglas performed a "Level one" safety review for all attending the meeting. Introductions were made and meeting moved to new business.

**Total Members Present:** There were Eight members.

<u>Recent Damages:</u> Ryan Smith with PNG stated that a contractor in New Bern, bored directly into an eight-inch main gas line and the contractor did not request a locate ticket. Rick Handlin with NCDOT stated that everyone needs a locate ticket from NC811. Whether it is a large project or simply installing a pole or sign in the ground.

#### **New Business and Projects:**

Ryan Smith, with Piedmont Natural Gas stated they are replacing and retiring a gas line that is approximately ten-thousand feet. Project is from Old Lowery Road to Mcloud Road in Lumberton. At this address is an older line which is three inches in diameter and they are replacing with a line that is six inches in diameter. New Federal law requires that main lines can be accessed and monitored with a "Pig" for leaks, defects, etc. The project should be completed by the end of January, 2019.

Tracy Maddox with Piedmont Natural Gas stated they have a new project involving the replacement and retirement of an old gas line. This replacement is approximately eleven-thousand feet. Project is also in Lumberton and scheduled to be completed by the first quarter of 2019.

#### **NC811 Presentation:**

Kevin Smith gave the NC811 presentation and reviewed the importance of contractors and locators working together. NC has the second largest call volume center in the country. Kevin stated contractors can assist in the efficiency of the locate request by doing the following. \*Wait until the 11<sup>th</sup> or 12th day to update a locate ticket. \*Contractors should be white lining the area they are going to excavate. \*Make certain white lining matches the locate request. (do not state locate entire property if area is indeed located) \*Only request locate tickets for the area in which you will be working in the next 3-5 days. \*Utilize Design Survey Tickets when possible. \*Contractors, reach out to your area locators and with good communication, let them know where you are actually working for the week.

#### **General Discussion:**

Rick Handlin with NCDOT stated he was very thankful for all the contractors whom has worked with him on various projects. He was very appreciative of the communication that he and others have built in the utility industry.
