# Safety Tips for working outdoors this summer



## **DRINK UP**

Thirsty or not, drink plenty of water – a cup every 15 to 20 minutes. Avoid caffeine or alcohol which can dehydrate you.

## **ACCLIMATIZE**

It takes time to adjust to working in heat. Work with your supervisor to gradually increase your work load and heat exposure.



# Safety Tips for working outdoors this summer



## **COVER UP AND PROTECT**

Wear light, loose-fitting clothing, UV rated sunglasses, and a wide-brim hat. Apply sunscreen with a Sun Protection Factor (SPF) of at least 30 and UVA / UVB protection. Re-apply every 2 hours and after sweating.

## **SHIELD FROM SUN**

Set up shade structures or use umbrellas, buildings, or trees to shield you from the rays of the sun. You can get sunburn on a cloudy day.





# Safety Tips for working outdoors this summer



## TIME IT RIGHT

Try and avoid the sun and strenuous tasks between 11:00 a.m. and 4:00 p.m. when the sun's rays are strongest.

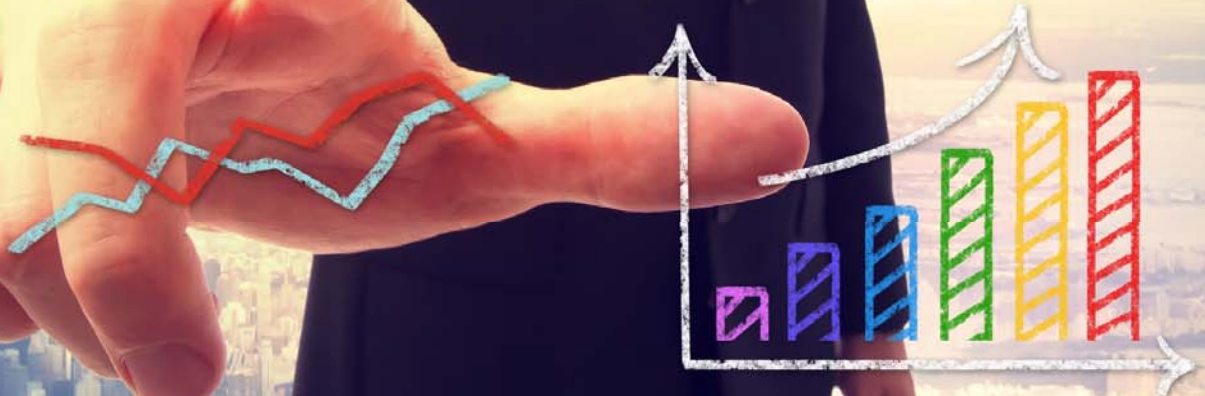
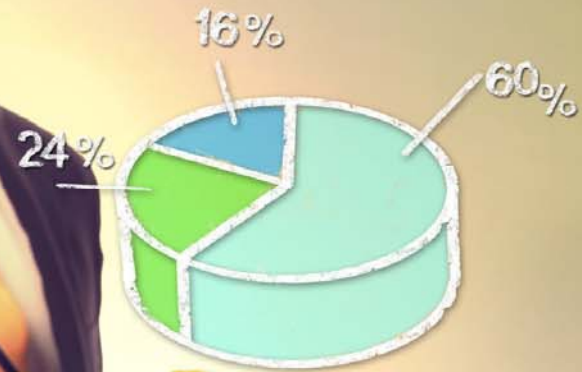
## COOL OFF

Lumberton Public Works

**Meeting Time:** The meeting was called to order by Kevin Smith at 9:05 am. Meeting was delayed with the anticipation of additional members arriving. Introductions were made and meeting moved to recent damages.

**Total Members Present:** There were five members. Chairperson Douglas Ward was absent.

**Recent Damages:**

Ryan Smith with PNG stated that they incurred a gas damage in Red Springs, near or on NC211. Damage involved a six inch gas main that was damaged by one of their sub-contractors.

**New Business and Projects:**

Kevin Smith asked the status of the new gas line being installed at Fort Bragg to Ryan Smith. Ryan stated that this project is proposed to be finished in the year 2023 to 2025 and consists of installing one-hundred fifty miles of pipelines.

Kevin asked if anyone had any experience in working with the company "Aqua" and if everyone was aware that USIC now performs their locating. This information was new for this group.

**General Discussion:**

Kevin asked if anyone had heard from the chairperson, Douglas Ward. Ryan Smith with PNG, stated he had heard that his mother in law (or other relative) was in poor health and perhaps he is out due to this.

Randy Webb with PGN, stated the person who was a pioneer of the 811 program was a native of North Carolina and their original telephone number was 800-632-4949.

Kevin asked for idea's to get additional members in participating within this particular group. Al Grimsley with Grinergy mentioned that we should reach out some of the local colleges to their maintenance departments, etc.

Kevin Smith with NC811 gave the presentation, with a strong emphasis of the meeting on the importance of working safely and keeping properly hydrated when working in the hot summer months. Meeting concluded after the general discussion. (above)
