- o Billy stated that the contract for the joint conference has been signed. Golf will be at the Sequoia National. Mark Hannah will be asked to oversee golf logistics

- o Donna agreed to assist Sandra with registration/Admin
- o Tim agreed to follow up on active-shooter speaker for joint conference
- o Billy asked about NCUCC Polo's for members

Reports

- o Greg w/DOT discussed their focus on project delivery. Also shared concerns with lack of response from utility owners with relocation, which is greatly slowing down the progress. This is costing tax payers millions. DOT is asking for better coordination and communication on utility moves
- o Ann asked if the DOT coordinators are attending local UCCs
- Due to lack of communication from utility owners, DOT division 10 has considered encroachment moratorium.
- Jody w/Charter offered to meet DOT to alleviate any issues involving Charter relocations
- o Greg w/DOT said they are meeting with City of Asheville to resolve these issues
- Andy w/Spirit Communication said they have 750 miles of new fiber in NC.
 Raleigh is slowing but Charlotte and Triad will increase in 2018. New contract with T-Mobile to bury fiber to 700 cell towers in NC/SC and work has started.
- o Chris Russ mentioned 700+ miles of 5G fiber will start in CLT & RLGH for 2018

- o Teresa mentioned their new locate vendor for 2018. No longer USIC for 2018
- o Ann asked if Piedmont and Duke had a new logo
- Wendy with Wilmington fire department thanked the group, especially NC811 for safety training
- o Billy mentioned that many of the local PSNC offices are partnering with local emergency services
- o Lower Cape Fear UCC had over 100 people attend the contractors luncheon. Has become more family oriented
- o Donna mention that Wake UCC breakfast had very little attendance by field workers
- o Ann with NC811 asked that local UCC's interact with local 811 representatives
- o Billy Rice adjourned the meeting
