#### **New Business**

- o NC 811 / One Call presentation was given by Informed the group that NC811 was notified that Direct Sat doesn't locate for CenturyLink, USIC has taken over that contract as of Monday, December, 2<sup>nd</sup> 2019. USIC should be up and running with those locates.
- Encourage everyone to start inviting their contractors to these meetings to help inform them of new laws and to network with the group.

### Open Discussion Reports

A. NC 811 / One Call – Brian provided us with the monthly 811 update. Also Brian talked to us about 811 having 811 come to your office and do an 811 Safety Presentation. Brian Morehouse went over the November 2019 presentation giving the totals for YTD and

Monthly number for Tickets called in, average locates per day and (3) hour tickets. (This is included as a PDF on the UCC website) Brian went over how to donate to the Food Banks and other organization to help those in need. Encourage all of those in attendance to help others during the Holiday season. NC811 went over some of the new laws and procedures that are now in effect as of October 1<sup>st</sup> 2019. Went over with every about the Liaison meeting that took place in Asheville back in November. Some of the things that are different with the other 811 locations. Talked about issues in the area with locates not getting marked on time and how emergency locates seem to never get marked. It was asked if Brian Morehouse with NC811 would reach out to discuss this issue with USIC. Brian Morehouse reached out to Jeremy Hussey, USIC, Supervisor on 12/6/2019 at 9:52 AM. Spoke to the group about 1,320 ft, ½ mile. (5) address and the single address rules. Gave examples of these issues to all and had a discussion on them.

- B. NC811 spoke to the group about hazards around the house during the holiday season. Don't plug to many things into one receptacles. Lock those doors, many thieves stalk the neighborhoods during this time of year. Always cut those boxes up and place in garbage can. Thieves will look over your property and can tell what you received for the holidays. Stay a step ahead of them.
- C. Deer is out and they will run in front of you in a quick second. Be careful and stay alert.
- D. Open discussion about contractors in the area and any issues with the way work is being done. See report below.
- E. Yadkin Water Authority- Having issues with contractor installing UG cable for Facebook has been damaging utilities throughout the area. Reported to Brian Morehouse and asked if NC811 would reach out to the. Brian Morehouse went out to where contractors for this project is located on 268, had a quick safety program with crew with Terran Tech about spot checking, bringing them up to date on new law changes that took effect on October 1st. Gave crews business card and asked for them to reach out if needed.
- F. Frontier Natural Gas- NA.
- G. USIC NA.
- H. **Spectrum-** Reports that they are very busy at this time with Fiber installation and service drops. Reports having issues getting many of their locates done on time and are having to reach out to get these locates done. Even (3) hour tickets are being attended too. Drop work is heavy in the area with no reports of issues. No major damages to report at this time.
- I. Surry- Yadkin EMC- Reports that they have 3-Phase project underway that is handled by Pike Electric. They are in the process of bring a new substation on line and work continues on that project over the next few months. No damages to report at this time.
- J. RiverStreet- Work load heavy and have no major projects to report. Cable installs and cable replacement. No major damages to report at this time. Interested in having more training from NC811 for their contractors in 2020. Did report that they are having issues getting locates done on time and having a problem with (3) hour tickets done. Seems they call locates in and they will get response usually by the (3) hour ticket is due.
