### Introduction of the Members and Guest:

Guy Smith with KCI Associates of North Carolina welcomed everyone again to today's meeting and a formal introduction of the guests and members from right to left announcing their name along with the company they are affiliated with.

### **Safety Moment:**

Don Proctor with Dominion Energy brought up the subject about red light runners. On his trip coming from North Raleigh to South Raleigh Office he saw three red light runners. Please remind yourself to scan the intersection before you approach them. You might be right, but you might be dead right. When you get to a stop sign, please make a complete **STOP** and look twice before you drive any further. Watch out for those of us who are on two wheels and four wheels as well. It's becoming a real problem.

### **Old Business:**

Sandra Johnson with Dominion Energy spoke about the upcoming contractor breakfast. The initial charge will be \$800.00 and that have been paid by Ken Griffin with PSNC Energy, Becoming Dominion Energy. It will take us about \$4,000.00 more to put this event on and sponsors and door prizes will ne needed. I will need to speak with Cassie about some concerns that I have but moving on for now. Guy Smith advise if you have door prizes we certainly would appreciate it as they are needed for this event. Also, Sandra Johnson advise would gather up some information about the contractor breakfast as management would like to see that in some sort of agenda or notification.

#### **New Business:**

Reggie Quander with Southern Cross advise that they are slammed on project. We have projects in Apex, Raleigh, and Durham. We are having the same issue with companies calling in 100 tickets at a time and there's just no way that you can work all those tickets. Then if you don't get to them then it turns into a three hour where you are working. I apologize that we are not getting the tickets worked in a timely manner and know that we are holding folks up, but right now just alone in Wake Forest we have about 300 projects and three hours of 100 of those tickets take away from other things that we need to do. We locate for PSNC Energy, Becoming Dominion Energy.

Robert Yu with USIC advise that the volume is up, and we are at a quick peak. We urge everyone to communicate with the technician or locators to not cause any corruptions or forbid anyone to get hurt. We want everyone to go home the same way as they arrived.

Critical Notification- Jimmy Petrie with the City of Raleigh advise that the contractors are doing a wonderful job out there. I would like to ask one thing. I have two supervisors who work for me and they both work Saturday and Sunday. We have two supervisors to watch pothole main. Please try to work with us on the weekend. If it's a commercial area that need to be done on the weekend that's one thing, but if it's a residential area try to refrain from the weekend. I'm not complaining as they do call.

Member advise that on the contractor side there's a huge amount of work and it's stressing the system big time. USIC and I meet regularly and standardize. We need to try to call in on what we only need. We are trying to manage and stream line things. There's a lot of work going on in this area and it's only going to get worse. We are committed to communicate and streamline. Just a two-way effective communication is the way that things must work. We've seen some improvements and hope that we can build from there.

ITS-Coaching Project Manager to white line jobs for locators. We also try to put a good person for contact on the locate ticket that knows the job and knows where it is going to start. We do joint trench, natural gas, and fiber. If the locator doesn't see the white line or white paint on the ITS jobs, then let me know as this is a good place to let me know. I think that white line helps a lot. White lining just tells you where we are going to be also good for micro trench. We are only going to go 8 inches deep just behind the curb. Reggie Quander with Southern Cross advise if you are putting down a white line then please make sure your ticket match what you are saying. We must do exactly what the ticket says.

### NC811 Presentation:

- Kevin Smith, Education Liaison for the Piedmont Triad Region presented the NC811 report for the month of March 2019.
- The NC811 Center statistics show that we received locate request totaling 167,125 in 2019 compared to 149,459 in 2018. That's a difference of 11.8%. Year to date tickets show 355,003 in 2019 and 301,918 in 2018. That's a difference of 17.6%.
- Transmissions locate ticket request show 910,174 in 2019 compared to 811,676 in 2018. Year to date tickets show 1,948,079 in 2019 compared to 1,653,587 in 2018. That's a difference of 17.8%.
- There was a total ticket volume of **20,614** for Wake County in March 2019. The average locate per day was **1,088**.
