Total Members Present

There was a total of **56** members present at the August Wake County Utility Coordinating Meeting according to the sign in sheet. **Members have been asked to please sign in so that an accurate count of attendees for each meeting can be documented.**

Welcome of Members and Guest:

Donna Zuniga with Duke Energy welcomed everyone to the **8th** UCC meeting of the year. Bathrooms are located out the double doors and straight down the hallway to the left. In case of a fire emergency, everyone should exit out through the double doors turn right into the hall way exiting out the door and walk towards the street and wait at the PSNC Logo sign at the front of the entrance.

Special Thank You:

Lunch was provided for this meeting by Kevin Comalander with Spirit Communications. Thank you again Spirit Communications for providing lunch for us during this meeting!!!

Blessing of the Food:

Blessing of the food was provided by Donna Zuniga before we started lunch which began at 11:01 am.

Introduction of the Members and Guest:

Donna Zuniga with Duke Energy welcomed everyone to today's meeting again and a formal introduction of the guests and members from left to right announcing their name along with the company they are affiliated with.

Safety Moment:

Donna Zuniga with Duke Energy provided a safety moment about her driving home to work one morning this week, it was dark, and all of a sudden she saw pieces of car parts flying in the air and a car was coming straight at her. She realized that the vehicle had a blow out and evidently

it hit so hard that the bumper and rubber was flying through the air. She said she just held onto the steering wheel and steered to the right towards the ditch. She was afraid if they didn't hit her then the person was going to hit someone else behind her. She pulled off all the way off the side of the road and watched in her rearview mirror until she saw them come to a complete stop and flashers came on. Just be aware and alert at all times as anything can happen at any time. Just be ready as it can just happen in a quick second.

Second Safety Moment:

School is now back in session and buses are on the road again. If you are in doubt if you should stop or not then just **STOP** to be safe and drive safely in the school zones.

Old Business:

Sandra Johnson advised that the contractor breakfast is coming up on Tuesday, October 24, 2017 at North Carolina State University Club. Sandra advised we are starting to prepare for our contractor breakfast this year. If you are able to contribute, please let Tiffany Elie, Donna Zuniga, or myself know. As far as I know everything is still on the go, but we still need help. You will still be able to pay with a credit card. I am hoping that this year Cassidy Parks will have someone available to take our credit card payments. Last year people had to go back and some people made payments over the telephone.

If your company is able to support this annual event that would be great as the cost for this event will cost us about \$3,500 to \$4,000 for the breakfast. Invitations will be mailed out in the next couple of weeks for people who don't attend the meeting. Again, the event date will be held on October 24, 2017 at North Carolina State University at 7:00 am. This event will take place of our regular monthly meeting date.

New Business/Concerns

Jimmy Petrie with the City of Raleigh advised he's noticing more contractors out of town that are performing fake pot holing of water mains. They are going out to the road and will dig a 6" deep hole and cold patch it and that's their pot hole. We are noticing it more and more daily. I guess they don't want to spend the money on permits or whatever it may be.

Will Shumaker with the City of Raleigh emphasize more if you choose to do that then you will risk your crew being shut down. Consequences of that is that your fines will cost you so much more. If any of your crews are doing that then let them know that it's 100% unacceptable and they will be dealt with strong consequences. As of right now there haven't been any damages. Right now the incidents are isolated, but it's starting to grow a little bit more. Hopefully people

are talking and the word is getting out about the incidents. That short cut just creates a whole other issue. We did have a 30" that's out on Strickland Road where a contractor made an attempt to pot hole where the bore came up and they were digging about two feet of a 30" main. If they don't think they will make the news if they hit that then they better think again. This time it was directional drilling and we tried to tell them and they advised that they will not do it and as soon as we leave they go right back to what they were doing. They will be the ones who will be screaming to the City of Raleigh when they are on the news.

Ricardo Hernandez with the City of Raleigh advised contractors will call the City of Raleigh and advise us they are here to spot the main, but the lines are not located. That's a good call, therefore, I will take it. Even a supervisor will if he have to go to locate the line. Once they have the line located then my team will respond and take measurements and pictures to make sure that you are safe. Once the contractor is onsite and they are ready to spot the main they can contact us and we may have someone available to spot the main as we want to protect our utilities.

Another topic brought up by a member was from an employee from Pike Electric was that there's a big project that's starting on 8-30-17. It will be at 401 and Ten Ten Road between Garner and Fuquay Varina. If you have been by that way then you have seen apartment signs out for rent, but the problem is that they do not have any power. I would image that there's other utilities in there so I am not certain what the problem may be. We have our tickets and positive response.

Betty Pearce with the Town of Wake Forest advised they are doing Public Power in the first week of October. We will do a lot of educational stuff and safety things like that. We do energy audits and electric safety. We also schedule the local schools for safety. We do from Pre-K to high schools. We have a lot of high school students who come in not realizing they can learn how to be a lineman.

Will Shumaker with the City of Raleigh advised Bob Busby will be handling the Northwest area of Raleigh. There's rumors going around that the City of Raleigh won't allow you to shut down sidewalks in work zones and that's not true. You have to call in a permit. It has to be approved for a work zone. When you shut something down and close it off then you need to have the barricade out, pedestrian control, vehicle control, and the proper access.

If you are a franchise utility company then the City of Raleigh is no longer charging a fee for closures and permits to work in accordance to the House Bill 310. You will still email the Right of Way Service Box. If in the day to day stuff you damage our infrastructure and you have to go back to do additional work then you will have to get a new permit for that. It's just for day to day normal work. Right now you are good, but the attorneys are debating on franchise utilities cost. As of right now there are no charge at this time.

City of Raleigh Transportation system have quite a few projects going on. Most of them are generated over the summer for Wake County Public Schools. Falls of Neuse, Neuse View, and

Rogers Lane we have that light activated. Oberlin Road and Dover Road, Strickland and Carriage Tour Lane, Six Forks Road and Snelling Road are still operational and trying to get these done. We appreciate you keeping your locates updated.

Spirit Communications advised they are averaging 400 to 500 feet a day and have had no issues. We are still rolling and should be finish up around December to January 2018.

Tony Mitchell with USIC advised one of the things he is noticing is there's are till 37% to 39% of contractors not calling in locate requests. It's not the homeowner not calling in, but it's the contractors. As far as the amount of damages being hit it's starting to climb. So there's are still a lot of people digging without calling in the proper locate ticket. As far as damages it will be hard to tell unless you see it, but there are a lot of damages being done out there. We typically see based on the numbers and we see about twice or three times of that in a month. For the most part there are a lot of damages without a locate ticket.

Sandra Johnson with PSNC Energy asked the question if anyone heard anything more in regards to fiber projects. We keep hearing a lot about fiber projects and that 2018 could be a nightmare. If anyone hear anything more of fiber projects coming into Wake County, please let us know.

Guy Smith reminded everyone that the Locate Resolution Partners Committee will meet directly after today's UCC meeting. We want to talk about how to make better process and tweet better locate request. If you are available then please join us.

Donna Zuniga with Duke Energy ask the question about what companies take pictures when locating? USIC take pictures when locating for us and the City of Raleigh take pictures as well. The Town of Wake Forest don't take any pictures. Sandra Johnson advised she's not sure if PSNC Energy locators take pictures, but S & N are contractors for PSNC Energy and they do take pictures for us when locating. It might be a good practice for everyone to take pictures when locating.

NC811 Presentation:

- The largest #1 NC811 Center is Texas and the State of North Carolina is #2.
- Jeff Bartley presented the NC811 report for the month of August 2017. The NC811 Center received locate request totaling 160,565 in 2017. The total locate request in 2016 was 166,259. This was a decrease of -3.4%. Transmission Locate request was 909,182 in 2016. Current Locate request in Transmission was 909,697 in 2017. This was an increase of +0.1%. The total number of State wide tickets for 2017 was 1,129,684 which was +2.7% over 2016. Total year to date of transmission tickets are 6,409,492 which is a total increase of +8.6% over 2016.
- There was a total ticket volume of **169,686** for Wake County in 2017. The average locate per day was **1,162** base on 146 work days.
- The total county ticket distribution in Wake County was 23,375.
