The Wake County Utility Coordinating Meeting was called to order by Mazetta Wynn at 11:03 am on March 27, 2018.

Total Members Present

There was a total of **40** members present at the March Wake County Utility Coordinating Meeting according to the sign in sheet. **Members have been asked to please sign in so an accurate count of attendees for each meeting can be documented.**

Welcome of Members and Guest:

Mazetta Wynn with PSNC Energy welcomed everyone to the **3rd** UCC meeting of the year. Housekeeping rules given out for newcomers. Bathrooms are located out the double doors and straight down the hallway to the left. In case of a fire emergency, everyone should exit out through the double doors turn right into the hall way exiting out the door and walk towards the street and wait at the PSNC Energy Logo sign at the front of the entrance.

Introduction of the Members and Guest:

Mazetta Wynn with PSNC Energy welcomed everyone to today's meeting again and a formal introduction of the guests and members from left to right announcing their name along with the company they are affiliated with.

Safety Moments:

Donna Zuniga with Duke Energy provided the first safety moment. She spoke about what Duke Energy is trying to make their employees aware of any time they are in a meeting or anything that's going on any time of the day is active shooters. That's something that they go over in every meeting. Just be aware of your surroundings and where you are at. If you're in a movie theater or out with your family in the mall or even just sitting here just think where would you go, hide, run, fight, and even play dead. It's a sad situation, but it's where we are at in today's time. Just keep in mind what you would do if that situation happened and how you would defend yourself and your family.

Second Safety Moment:

A member wanted to remind everyone about spring break coming up and more inexperience drivers are on the road and more traffic on the road and in the road.

Third Safety Moment:

Mazetta Wynn with PSNC Energy talked about the weather outside and when it's raining please take your time driving by keeping the same speed, but try to drive just a little slower. Watch out and do not use cruise control when it's raining or any bad weather.

Fourth Safety Moment:

Old Business:

Tim Yarbro with Anso and Associates advised that we have about 140 that have register so far and there's approximately 32 vendors that have register as well. Sponsors are working out very well and if there's anyone who want to sponsor please get with us on it. Tim mention that

there will be a golf transportation on Wednesday morning, May 2, 2018 at 10:30 am if anyone want to ride a bus. He believe it's going to be Badger Daylighting that is actually sponsoring that bus. Anyone who want to ride that bus it will run from 10:30 am to 6:30 pm on Wednesday, May 2, 2018.

New Business/Concerns:

A member advised that they work for the City of Raleigh called in which they call in a various amount of locate tickets and a lot of the tickets are coming back saying locator and excavator. Why is it coming back like that and we aren't speaking with anybody? Another question is a recent job that occurred at night and found a wire just underneath the asphalt. He called NC811 to do a damage and a ticket to get a contractor to come out to take a look at the utility at it and he was told to call back in the morning for damages. This happened at about 12:00 am. Louis Panzer with NC811 advised when you called in we only take emergency tickets. There's a difference between emergency locate ticket and a damage locate ticket. We don't take a damage ticket, but we change our process now to ask as most people know as I listen to the recording myself and when she told you that it couldn't be done as it was a damage, but what you said we are on site requesting an emergency locate then absolutely we would have taken the emergency locate ticket request. One thing we are doing internally is asking someone if they are calling us after hours are they doing the emergency locate and then that give you the opportunity to say yes. You may not have realize the difference of the two, but if we know you are out there then we would have totally taken care of that ticket.

Members brought up having the correct contact name and number to reach out to companies. We've had contact information in the past, but not anything recently. Sandra Johnson advised she have tried to gather information from our members last year, but no response from anyone that they were interested in it.

Guy Smith with PGI Incorporated advised everyone in the monthly local UCC meeting to take advantage and develop your one on one relationship with members. It's a tremendous opportunity to meet the people with the boots on the ground.

Projects:

Spirit Communications advised they are wrapping up and selling services. Billboard are going up around Raleigh. They are cranking up the marketing as well.

Dixie Pipeline-Tony Armen advised to members that not all 811 centers are equal. Some things that North Carolina offer, but South Carolina don't offer. You can review a near ticket to see if there's something out there for a near job. Louis Panzer with NC 811 advised that we have over 17,000 on the app that have enhanced positive response with tools and education that come along with it.

Charter advised there's no major projects going on just the usual. They are down about 20% on damages year to date. Ticket volume seems to be up a bit. Education and training provided to the excavators and contractors on how to identify the cause and effect of nicks and flat spot of cables. We are always available to help with that and thanks to all of you for the lack of damages this year.

Member advised of one big project that is coming in Southside Project. It is scheduled to kick off in October. That will be phrase I which will be 401 to 40 then jump over to Westside and catch the Holly Springs extension to 540 to 401 then they will just to the Eastside to 40 to 540 to Knightdale. We've been attending a lot of meeting with DOT and that kick off is expected in October.

There will also be another big project heading our way at Aviation and 40 where a lot of companies are having to relocate their lines.

NC811 Presentation:

- John Conner is the new liaison for the Piedmont Triad Region. John Conner presented the NC811 report for the month of January 2018.
- The NC811 Center received locate request totaling **149,459** in 2018. The total locate request in **2017** was **147,102**. This was a difference of **+2.5%**. Transmission Locate request was **822,463** in 2017. Current Locate request in Transmission was **826,109** in 2018. This was a difference of **+1.9%**.

- There was a total ticket volume of **41,025** for Wake County in 2018. The average locate per day was **977** base on 42 work days.
- **County Ticket Distribution** was a total of **19,904**. The **Raleigh** area have the highest number showing a total of **8,161**.
