Meeting Time:

The Wake County Utility Coordinating Meeting was called to order by Mazetta Wynn at 11:01 am.

Total Members Present

Welcome of Members and Guest:

Mazetta Wynn with PSNC Energy welcomed everyone to the **9th** UCC meeting of the year. Housekeeping rules given for newcomers. Bathrooms are located out the double doors and straight down the hallway to the left. In case of a fire emergency, everyone should exit out through the double doors turn right into the hall way exiting out the door and walk towards the street and wait at the PSNC Logo sign at the front of the entrance.

Introduction of the Members and Guest:

Mazetta Wynn with PSNC Energy welcomed everyone to today's meeting again and a formal introduction of the guests and members from left to right announcing their name along with the company they are affiliated with.

Safety Moment:

Two occupied, transit vans with 20 day tags, caught fire, due to the exhaust system blowing down. It seems that a transit van put out a whole lot of heat causing the exhaust pipe to catch fire at the bumper. This is the second situation, like this in 45 days. Everyone is okay including the driver.

Second Safety Moment:

Two months ago a contractor stepped on a hole and had to have surgery on 70% of his muscle. Watch out for the holes in the sod.

Third Safety Moment:

Mazetta Wynn with PSNC Energy spoke about storms. We are in our severe storms and hurricane season and just be prepared and make sure you have your check list. There could be loss of electricity, falling trees, flooding, and severe flooding in the road.

New Business/Concerns:

No New Business at this time.

Contractors/Locators Concerns:

Member spoke about receiving an email from Louis Panzer with NC811 reference to filling out a survey about our Utility Coordinating Meeting. Comment thoughts was that we have a great group and a lot of participation as a group and people feel comfortable being here. The concern that we have is the lack of participation from our contractors. There are a huge amount of franchise owners that have contractors and listening to Tony at the last meeting about the large percentage of contractors not calling in locate tickets. So somewhere there is a huge disconnect and we don't have the answer for it. We just hope that the members of this group will have some ideas of reaching out to our contractors to get more involved. It doesn't appear that we are reaching out to these contractors to get them involved and to get them to come to our meetings. That was my comments to the survey. We just didn't have a good answer as to the best way to achieve this problem.

Facility owners talk to your contractors and invite them to our local UCC meeting. If there are contractors out there then talk to them and invite them to our meeting. Spectrum require their contractors or those that work underneath them are required to be at the UCC meeting and we are required to report all of our locate and ticket numbers. That's one way to do it as to make it mandatory for them. There were approximately five or six contractors from Spectrum present at our meeting today.

Sandra Johnson with PSNC talked about what happened in her neighborhood. We had a home that was sold very small two street subdivision that she live on and the person who bought the home is doing a total renovation and he had hired someone with heavy equipment to come in and remove most of the trees and she was talking about backhoe, etc. It was very huge equipment and they have not called in the first locate request at all. They cut the power cable according to the neighbor. They haven't contacted Duke Energy to put it back. Evidently someone put that cable back together as they do have power. She drove by there Saturday morning and took pictures of the equipment and address and sent it to Donna Zuniga with Duke Energy. She was out of town, but she answered my telephone call and I sent her the pictures. The owner have said to everyone that he don't need all these permits and that he is too far back and no one is going to know what he is doing. Anyone with the City of Raleigh who have any idea about inspections or whatever that address is 4821 Leven Lane, Raleigh, North Carolina.

Charter: Business as usual. Just continue to put everything back together.

Mr. Levine with Spirit Communications advised that Spirit is moving around. There are some issue with permits, but coming along well. We should be done in Wake County going to Durham County, Orange County, and Forsyth County next in line.

City of Raleigh-Everything is working. It's very busy and everyone is doing a lot. Just be cautious getting in the roadway. Make sure your maintenance signs are set up. We are starting

to get a number of complaints and just trying to keep everyone safe. That's our main concern. We want you to be safe when you are doing it. Just take that extra time and be safe. It's not just us forcing anything, but just looking for traffic control.

PSNC Energy- Cort Bennett advised that all is good. There are leak survey going on and more leak repairs. Other than that all is good.

Robert Yu with USIC advised that October is the biggest month of the year. Everything is more the same at this time.

NC811 Presentation:

- Jeff Bartley presented the NC811 report for the month of September 2017. The NC811 Center received locate request totaling **178,099** in 2017. The total locate request in **2016** was **196,915**. This was a decrease of **-9.6%**. Transmission Locate request was **1,076,866** in 2016. Current Locate request in Transmission was **1,000,845** in 2017. This was a decrease of **-7.1%**. The total number of State wide tickets for 2017 was **1,307,783** which was **-0.8%** over 2016. Total year to date of transmission tickets are **7,410,337** which is a total increase **-6.2%** over 2016.
- There was a total ticket volume of **196,387** for Wake County in 2017. The average locate per day was **1,169** base on 168 work days.
- The total county ticket distribution in Wake County was **26,701**.
