Howard Corey welcomed all guests! Bill Plount went over a safety minute and reviewed meeting places in case of an emergency.

Previous minutes were read by Secretary, Jennifer Christman.

Howard Corey, NC811, started the meeting out by showing us some photos of some locates and one of 1800 pound co-op cable that was damaged in the amount of \$14k.

In our January meeting we had ordered shirts to help celebrate NC811's 75th Anniversary, those shirts have arrived and Howard distributed them.

Wayne County currently has a 6% increase in locate tickets since 2016 and Year to date we have seen a 13% increase. Transmissions have increased an average of 11% since 2016 as well. Wayne county is currently averaging 62 locates per day.

Mr. Corey reminded everyone when using the RTE (Remote Ticket Entry) that is it important to choose which type of ticket you are needing.

NC811 offers free utility damage training online, this class takes about 1 hour to complete and can be found on the ncpipesplus.org website.

You can now find the CGA tool, this useful tool has identified and validated best practices.

The Fire Marquee challenge is still ongoing.

The Underground Damage Prevention Review Board will meet again on April 18th in Raleigh.

The State UCC meeting will be April 5th in Myrtle Beach, SC- make sure you register if you plan on going.

NC811 has partnered with Lowes! Lowes will be placing tree wraps on their trees to remind homeowners to call before they dig. You will see this in their 1840 locations across the country!

Meeting was ended with a roundtable discussion.

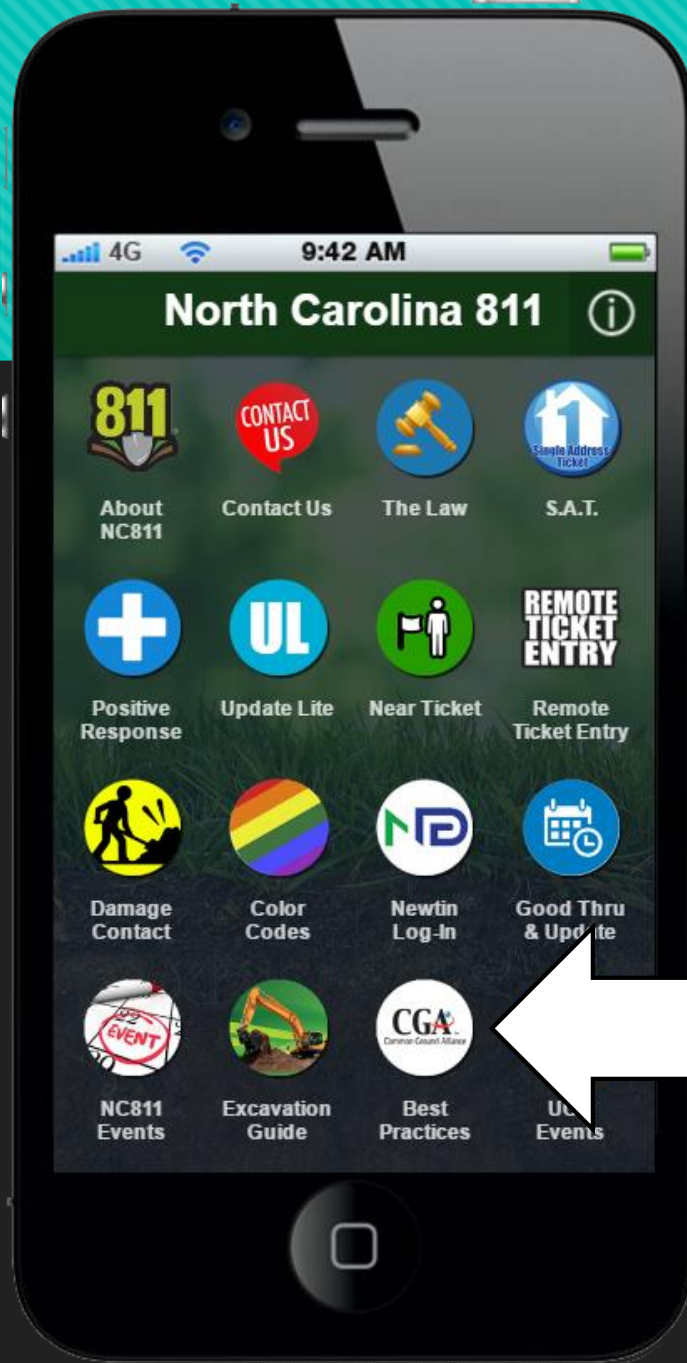
