**Current Mission:** A collaboration of damage prevention stakeholders partnering to reduce damages through data analysis and educational outreach.

### Meeting called to order by Chairman Dino Farruggio at 11:00 am.

- Introductions were made
- Louis Panzer spoke about the data within the reports and continue to suggest that what is going on is still noise in the system.
- Jason Williams with Centurylink is having an issue with subs of Segra around their facilities. Kevin Comalander with Segra will make sure CL is added to the conference call each week.
- Google is working in several different Counties that include Wake and Mecklenburg. Using micro trenching in Cary. The primes on the project are ITS, Hypernetworks and Quanta. Google has shrunk the polygon around their facilities. Down in Charlotte they are doing traditional boring through May of 10 to 15K feet each month. Will then pick up 2 to 3X in June & July.
- The reports for December 2019 & January 2020 of updates with 1 day or less for work duration, excessive updates and destroyed marks was discussed. Stakeholders will review and address concerns with their contractors.
- Louis discussed the 2<sup>nd</sup> letter that was drafted in the past for offenders that no response was received from the 1<sup>st</sup> letter. It would include language of historical history of excessive locates and require a response to remediation. Committee will discuss at the next meeting.
- Louis gave an update of the UGDPRB. Invoices scheduled to go out to the top 50 receivers of transmissions soon. From there, an RFP will be drafted for administration of the Board.
