- **Web TMS exe being phased out in 2021**
- **All users are being migrated to the new HTML5 version**
- **Benefits include:**
 - **Ability to import shape files and view the imported layers over the ticket**
 - **Auto respond to tickets**
 - **Ticket alerts and escalation ability after a set time**
 - **Ability to assign to a locator account that can then post to positive response**
 - **Able to still use online/offline**
 - **Able to be used on multiple platforms including tablets**

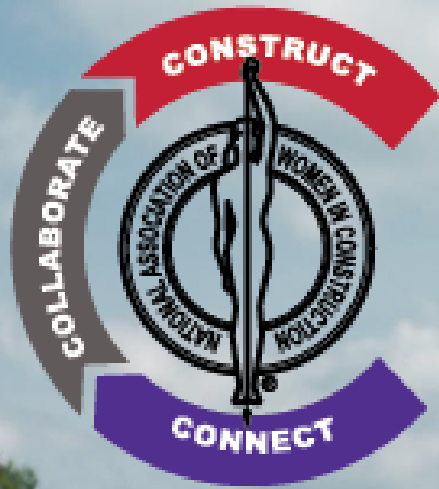
