**SREMC** – Subdivision extensions in Harnett County at Anderson Creek Golf and Rolling Springs near Anderson Creek.

**NCDOT** – Construction on Hwy 70 toward Smithfield to upgrade to Interstate status, project on Hwy 42 East and West, round-a-bout project at Cornwalis and Josephine , Hwy 42 bypass, Archers Lodge area.

**Cable East** – Broadband Infrastructure project on I95 starting at the I95/Hwy 70 corridor Selma going north toward Virginia.

Parrish presented the NC811 report, overall locate tickets were up 8.9% from last year. Harnett County had a 10.2% increase in locates and Johnston County had a 3% increase. The highest number of tickets in Harnett County were from Lillington and Angier; the highest in Johnston County were in Clayton and Smithfield. Parrish' presentation included some back to school tips to help your children succeed, he also spoke about school bus safety.
