- · Damage Reporting: It is YOUR responsibility to report ALL damages to underground utilities. The reports must be reported to the NC 811UCC offices in Greensboro.

Round-table Discussions:

David Perkins – Brentwood Water: Business as usual. We have been able to catch up on all leaks and currently up to date on tap installations.

In the process of tying in thirty service lines to the newly completed Denton Chapel Road upgrade project. This newly installed line is one mile long.

We are getting ready to start another project of replacement water line upgrade on the David Bryant Road. This is 1,000 feet in length; serving around fifteen customers.

Jim Buckner & Rodney Roland – REMC: Transmission line upgrade has been completed. Currently involved in a massive "Pole" change out project. We will be removing and installing approximately 300 poles. This is Burke and McDowell County wide project.

Richard Lawrence - PNG: Currently installing a "New regulation Station" across the street from the NC School for the Deaf on Burkemont Avenue. This station has four different pressures. The inlet pressure is 600-pound and is zoned off to 60-pound zone; 100-pound zone; and 150-pound zone. These different pressures are sent out to various parts of the City of Morganton.


Just completed a 17-mile line replacement project from Lenoir down US Hwy 321 towards Hickory. A 250-pound 4-inch metal line was replaced with a 60-pound 8-inch plastic line.


