- **Remember!** If you hit an underground objective, and you think it is a Gas Line, do the following in this order:
 - Call 911 to report the accident!
 - o Call the Gas Company and let them know the specifics concerning the damage!
 - o Call 811 to report the accident to our office!

• <u>Damage Reporting:</u> It is <u>YOUR</u> responsibility to report ALL damages to underground utilities. The reports must be reported to the NC 811UCC offices in Greensboro.

Round-table Discussions:

<u>Ralph Johnson – Brentwood Water:</u> The Denton Chapel Church Road service line change over from the old main line to the new main line should be completed by our service technicians this week.

We will be starting a new installation project on the David Bryant Road off of the Kathy Road in the very near future. The contract has been awarded to the Iron Mountain Contract of Mountain City, TN. This project will consist of installing new water line on the state highway right-of-way and getting our current line off of private property and out of wooded area which is very hard to service.

<u>Jim Buckner & Rodney Roland – REMC:</u> Nothing new to report. Still changing out old poles in the Burke and McDowell Counties. This project is requiring the changing of 100s of old poles.

<u>Doug Suttles – Suttles Surveying:</u> Still remain very busy. Right now, there is a 32-week lead time to get any additional projects in the pipeline for service.




