Women in Construction Week: March 6-12, 2022

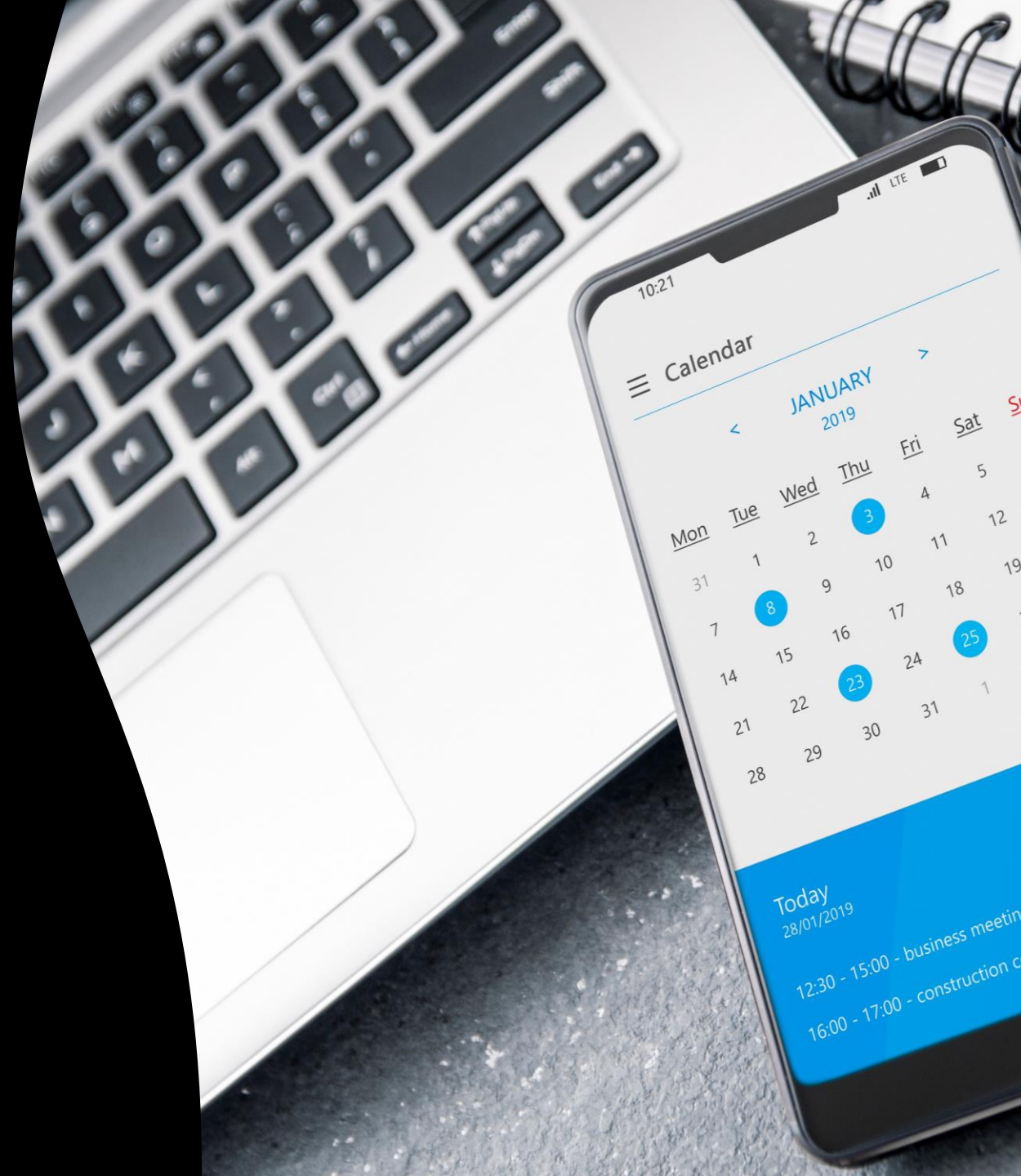
