

- **Remember!** If you hit an underground objective, and you think it is a Gas Line, do the following in this order:
  - Call 911 to report the accident!
  - o Call the Gas Company and let them know the specifics concerning the damage!
  - Call 811 to report the accident to our office!
- <u>Damage Reporting:</u> It is <u>YOUR</u> responsibility to report ALL damages to underground utilities. The reports must be reported to the NC 811UCC offices in Greensboro.

- I. Town of Waynesville- Working with NCDOT with new round about, relocation on Deval St. New 115 lot subdivision has been approved, will be phase 1 of that project. New drain lines being installed along Kentucky dr and Virginia Dr, will take (5) months to complete.
