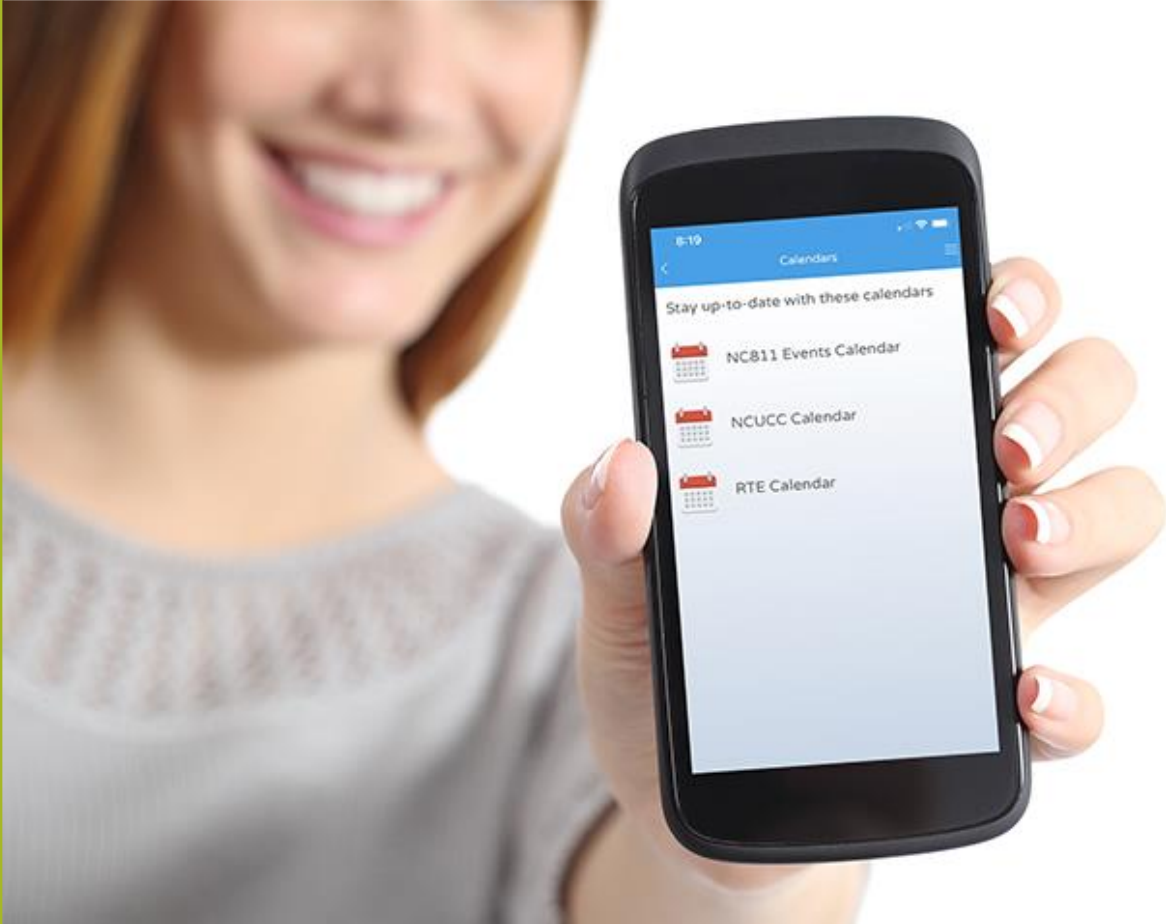

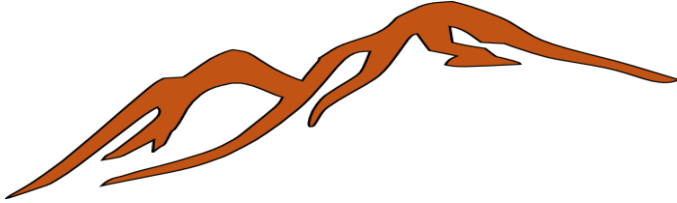

- **Remember!** If you hit an underground objective, and you think it is a Gas Line, do the following in this order:
 - **Call 911 to report the accident!**
 - **Call the Gas Company and let them know the specifics concerning the damage!**
 - **Call 811 to report the accident to our office!**
- **Damage Reporting:** It is **YOUR** responsibility to report ALL damages to underground utilities. The reports must be reported to the NC 811UCC offices in Greensboro.

- Dominion Energy** – NO major damages to report in the area. Maint work continues no large projects underway at this time. They do have two new employees being trained in this area.
- USIC** – Staying busy- have two locators within the area Tickets have been high here of late but staying on top of matters and have had no issues with contractors in this area since the last meeting.
- Southern Cross Locating-** Tickets have started to pick up with spring is here. Fully staffed and keeping busy. No issues to discuss at this time

- I. **Town of Waynesville-** Working with NCDOT with new round about, relocation on Deval St. New 115 lot subdivision has been approved, will be phase 1 of that project. Work has not started there yet, will be in the summer of 2022. Also mentioned the two-story building in town that will be starting and will have to reroute main line. **New drain lines being installed along Kentucky dr and Virginia Dr, will take (5) months to complete.**
- J. **Reported that they are having issues with not enough information provided on the tickets and it is taking them hours to locate unnecessary ares.**
- K. **Spectrum-** Told the group that 2,900 miles of new fiber will be installed to the house. Looking at doing 500 miles per year in the western region of NC. Have crews in area working and installing the new fiber
