



- **<u>Remember!</u>** If you hit an underground objective, and you think it is a Gas Line, do the following in this order:
 - <u>Call 911 to report the accident!</u>

<u>Call the Gas Company and let them know the specifics concerning the damage!</u> Call 811 to report the accident to our office!

• **Damage Reporting:** It is **YOUR** responsibility to report ALL damages to underground utilities. The reports must be reported to the NC 811UCC offices in Greensboro.

Problems with Century Link and also Duke Energy, getting those</u> <u>locates cleared. A number of people complained that locators are not</u> <u>responding to emergency locates nor calling</u>
