

### Apartments on 1 parcel with multiple addresses




A ticket for each building address on the one parcel, helps both the excavator & the locator.



- **Damage Reporting**: Remember that if you damage an underground utility, it is **your** responsibility to report this damage to NC 811 UCC. Offices in Greensboro.
- Below is the website where you can go to communicate "Damage Violations." <u>https://www.nc811.org/report-a-violation.html</u>
- **<u>Remember!</u>** If you hit an underground objective, and you think it is a Gas Line, do the following in this order:
  - Call 911 to report the accident!
  - Call the Gas Company and let them know the specifics concerning the damage!
  - <u>Call 811 to report the accident to our office!</u>
- **Damage Reporting:** It is **YOUR** responsibility to report ALL damages to underground utilities. The reports must be reported to the NC 811UCC offices in Greensboro.

#### Brian Morehouse – NC 811 Comments:

- If you do not already have the NC811 app installed on your mobile device, get it, it is a helpful tool to use in your daily jobs.
- If you have damages made to your systems, you can look into filing a complaint with the UGDPRB. Please visit the udprb.nc.gov website for more details. Remember, to take several photographs from various angles to be submitted with your written claim.
