

- Meeting started at 11:30 am
- NC811 presentation given by Tyler Ross
- First Tuesday in April, 4/4 for contractor breakfast at Honey Badgers field. Reach out to contractors and other folks who work with and for you.
- Dominion O&M- maintaining steady work.
- Town of Shelby- had a homeowner call in and a certain facility wouldn't call in. Will reach out to Tyler next time.
- Dominion distribution- issue with locater. Richard shed light on what is going on. "Scrubbers" oversee the ticket from a remote place and will clear ticket. In the case it is known there is any facilities present they asked to ask for a 3 hour ticket.
- NC DOT had question on mapping and imagery. Tyler recommend he would connect them with Marshall
- J&G spoke on a call and locate for a gate/fence and received a letter stating they cut a cable and AT&T sent the letter. Never heard from anyone.
- Gastonia- busy.
- Linking to use Tamis flyer for Iredell. Tyler will talk with Tami.
- Richard asked about vendors being at Contractors breakfast.
- Dominion introduced Joe who is coming to Dominion to cover Dominion for NC DOT.

- Vemeer said utility equipment is several months out. If anything is needed, better get it in. Will be at the contractors breakfast as well as NC/SC Joint Conference in Cherokee.
- Scott and Tyler will get together on moving to Rutherfordton next month.
- Update tickets up by 39% on Dominion. Due to fiber sub-contractors.
 Could be a breakdown in communication from crew to office.
 Recommendation was to make the updates more difficult.
- NC DOT had questions about how often data is updated for NC 811.
 Particular to as builts. Concern that NC DOT has information that we don't know about. Tyler will get with Warren to work with 811 on updating and developing a better system with Division 12.
- Discussion on fiber expansion.
- Meeting adjourned at 12:26 pm when food was brought out.
