



**Jones - Onslow
Utilities Coordinating Committee (UCC)
Meeting Minutes
April 20, 2023**

This meeting began at 11:36 am and was held at the Tar Landing Baptist Church gym. Onslow Water & Sewer Authority sponsored lunch.

Chairman Ralph Murphy welcomed everyone and asked that they please sign in and silence their cell phones. He also welcomed all the newcomers to our UCC Meeting and thanked ONWASA for providing lunch.

Howard Corey (Education Liaison with NC811) reviewed the NC811 updates and data on locate tickets and damages in our area. Ticket volume continues to increase, and projects are on the rise. April is safe digging month.

Chairman Ralph Murphy spoke about the 40th Annual Joint NC/SC UCC Conference from May 3rd thru May 5th. The registration fee is \$125 per attendee which increases to \$150 after April 21st. Come join us and help represent our UCC!! Visit <https://ncucc.org/joint-nc-sc-uccc/> for more information.

Ralph also discussed issues with companies asking for miles of locates to be done, instead of the actual area where the locate is needed. He also advised locators they should communicate with contractors/excavators and make a verbal agreement to be contacted when they are ready to perform the work.

Member Updates:

PLURIS – Working on two RV parks coming in – one at Turkey Point and the other at the intersection of Clay Hill Rd and Old Folkstone Rd, also Sneads Ferry shopping center across from Food Lion, North Point Bay, and Evolve @ North Shore.

Environmental Management Services – Randy Hoffer (Formerly with PLURIS) has his own business working on LPP septic systems, grinder pump systems, small package plants, water systems, etc.

Piedmont Natural Gas – Douglas Rd and Hwy 17, Hwy 24 from the main gate to the railroad track, many small projects and sporadic services; Marsoc project and Hwy 258 project soon to be gassed up, and several projects are waiting on encroachment agreements.

ONWASA – Staying busy, ONWASA Safety Officer says to start now preparing for hurricane season. Meters Supervisor, Kurt Jones asks that if someone hits a water line, please stay there with it until ONWASA staff arrives. Technical Services Supervisor, Wynne Ray reports that new plan approvals are the North Topsail Fire Station #2, North Pointe Bay, a medical office park in Richlands behind Dollar General, Harbor Watch phase 1, North Topsail Landing, Evolve @ Holly Ridge, and Vineyard trails. She also mentioned that if you need water on-site for a project, you must come to the ONWASA office to get a hydrant meter. There have been incidents of illegally connecting to the ONWASA water supply.

METRONET – Working down Gum Branch installing fiber in Lauradale Subdivision, on Rocky Run, Old 30, Town Point, Carolina Plantation, Brynn Marr, and Raintree Subdivision. Trying to keep quality contractors.

USIC – Staying busy, re-organizing staff, and still hiring.

Stake Center – Extremely busy; Hiring in the Wilmington area.

Brightspeed – Staying busy

Onslow County Planning – Carter Metcalf reported upcoming projects at Town Point at Onslow Bay, Patriot Point, Peyton's Ridge, Sandy Hollow, an RV campground off Duff Rd, and duplexes on Murrill Hill Rd.

JOEMC – Very busy, having power outages due to wildlife, overhead lines being hit by dump trucks or construction equipment, etc. Please report any incidents you see. Lines on the ground can still be energized. They are also replacing old transformers. Piney Green Rd maintenance by their contractor. Busy installing power in new subdivisions.

The City of Jacksonville Emergency Fire Marshal – Fire Marshal Brian Kelly has been working with Sides Construction behind River of Life Church and on other small projects. He reminds people to follow the burn bans and DO NOT burn if conditions are dry or windy. Brian also reminds everyone to stay hydrated because what you drink today is what you will sweat out tomorrow.

This meeting ended at 1:20 pm., and there were 28 attendees.





County Ticket Volume






