SREMC – Johnston – Hannahs Creek Subdivision and maintenance work, Harnett – Anderson Creek Golf extension and Overhills Creek Extension, new subdivision off of Nursery Rd – Mason Ridge, Boone Trail village project.

NCDOT - Harnett – I95 project utility relocation is ongoing, bridge projects on Langdon Road, Hwy 27 bridge over Little River, Angier bypass project, round-a-bout in Buies Creek. Broadband project down I95 in Cumberland County.
