- Encourage workers to wear sunscreen and use other protections from direct sunlight

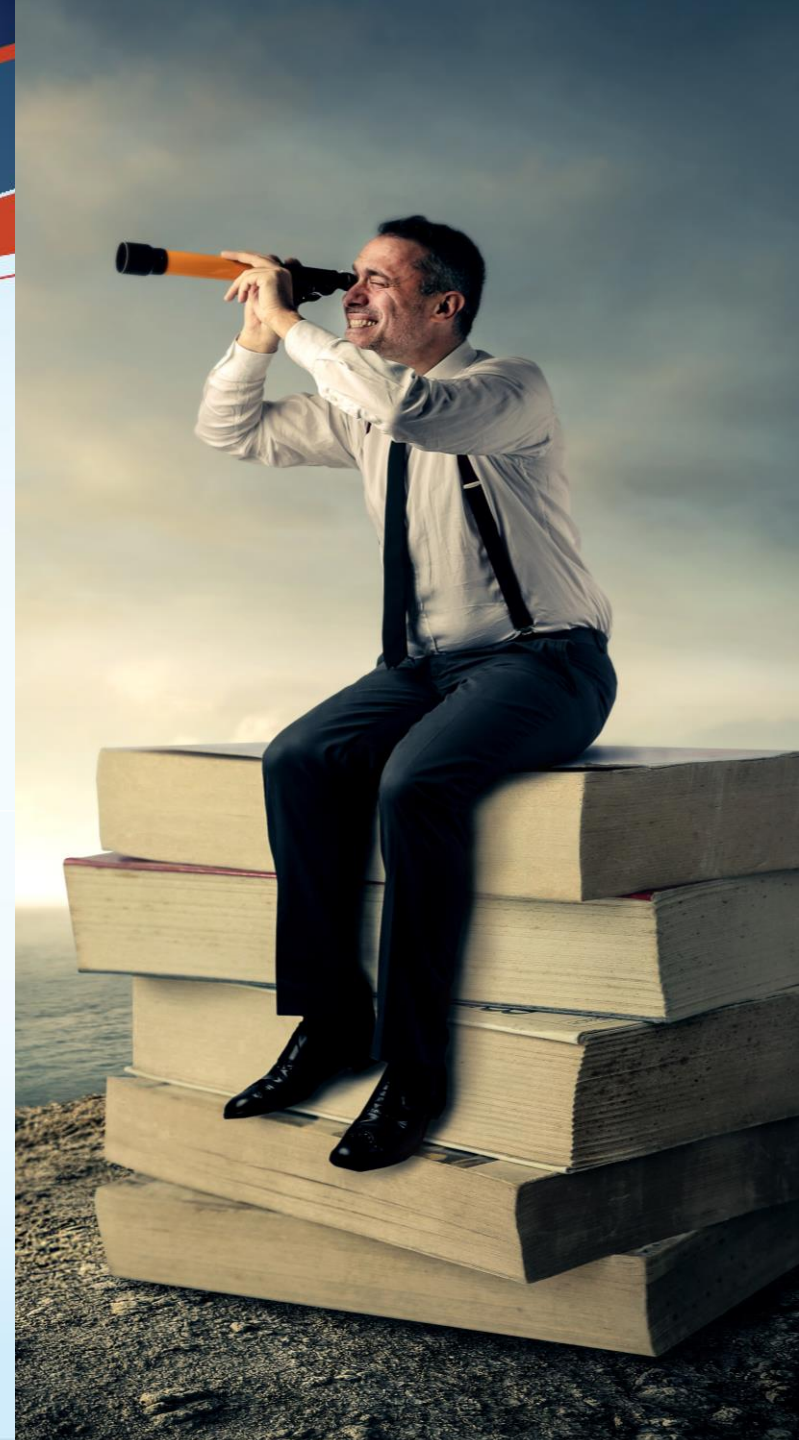

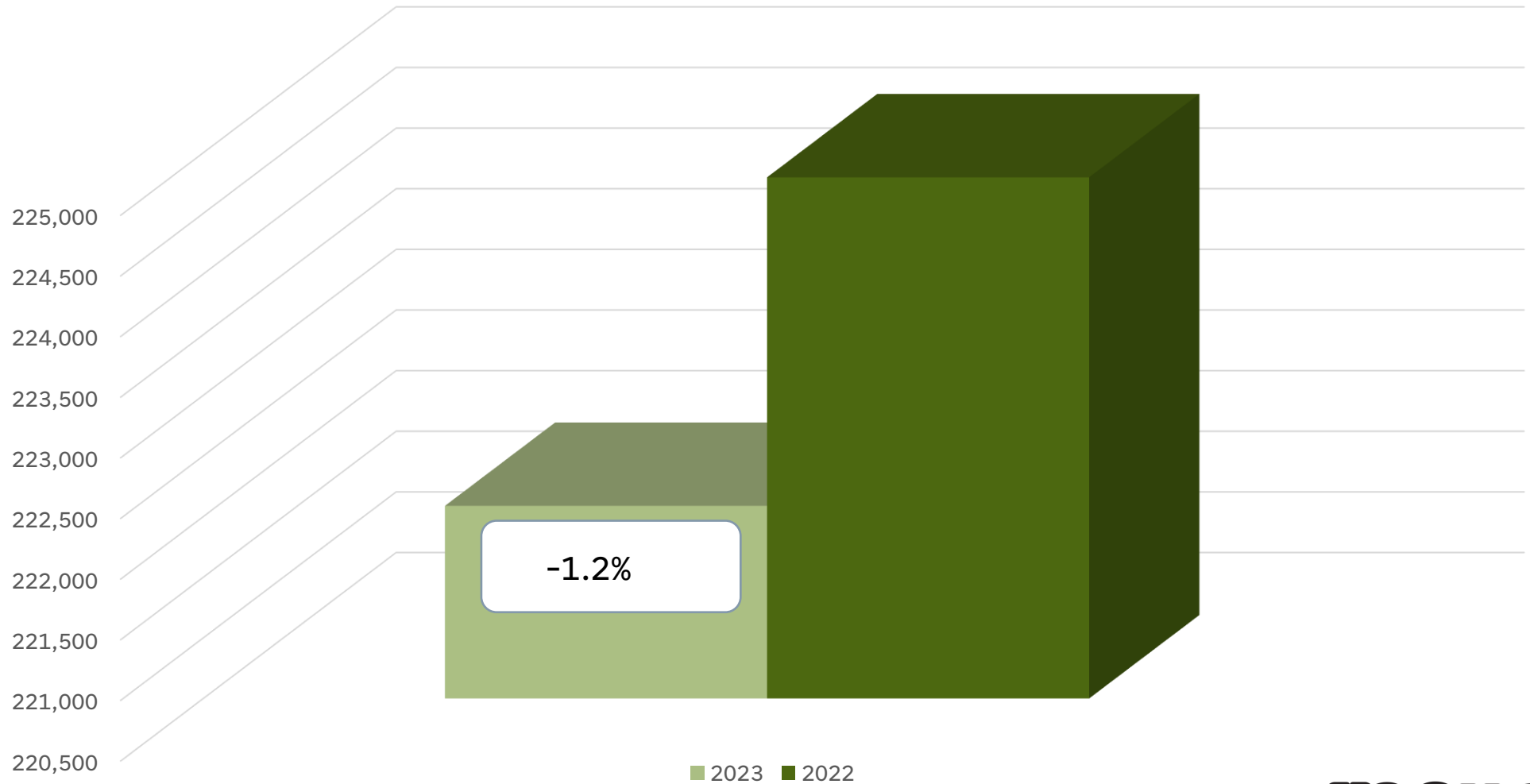

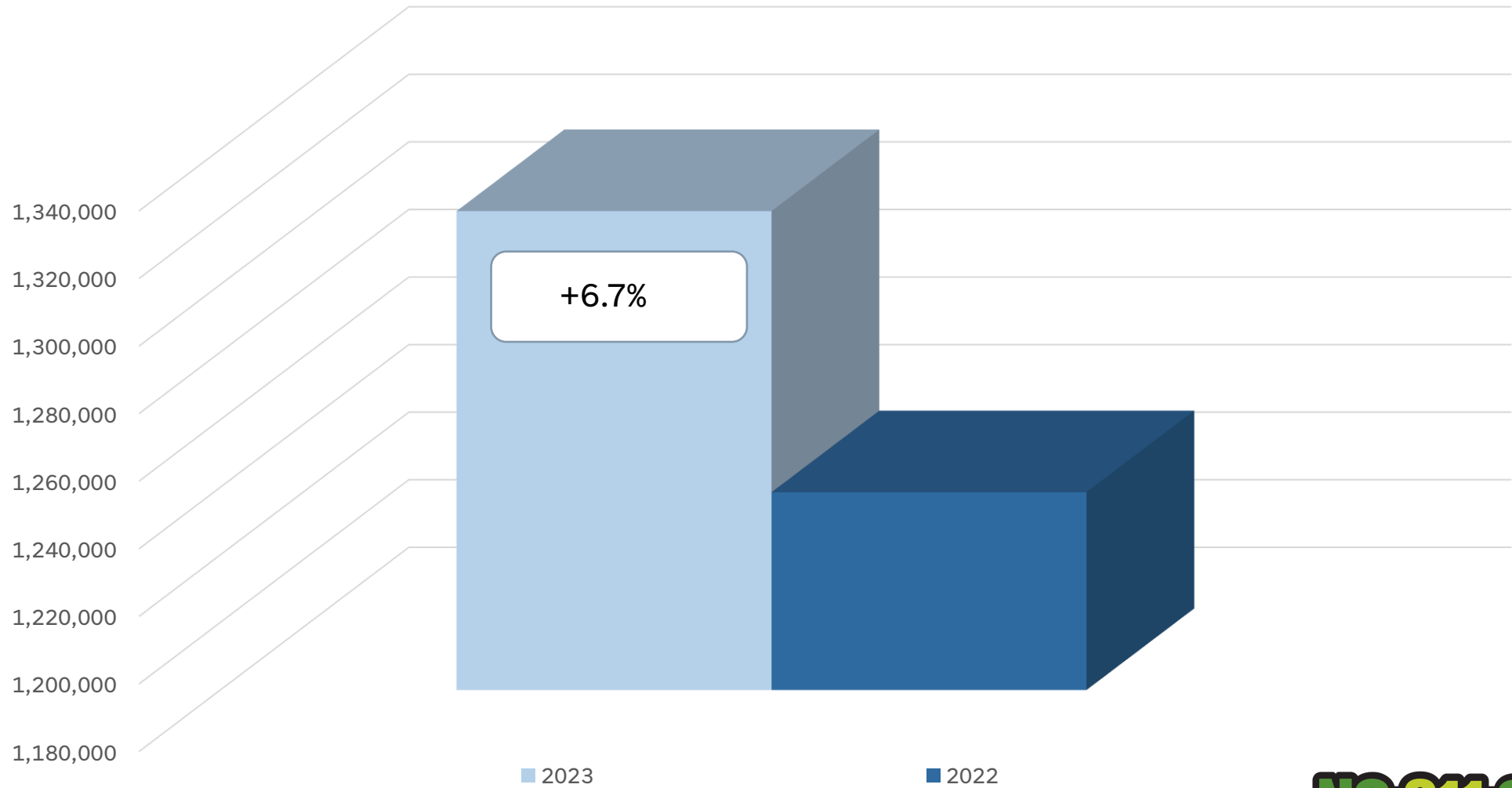
# Locate Requests for NC

## JUNE 2023 vs 2022



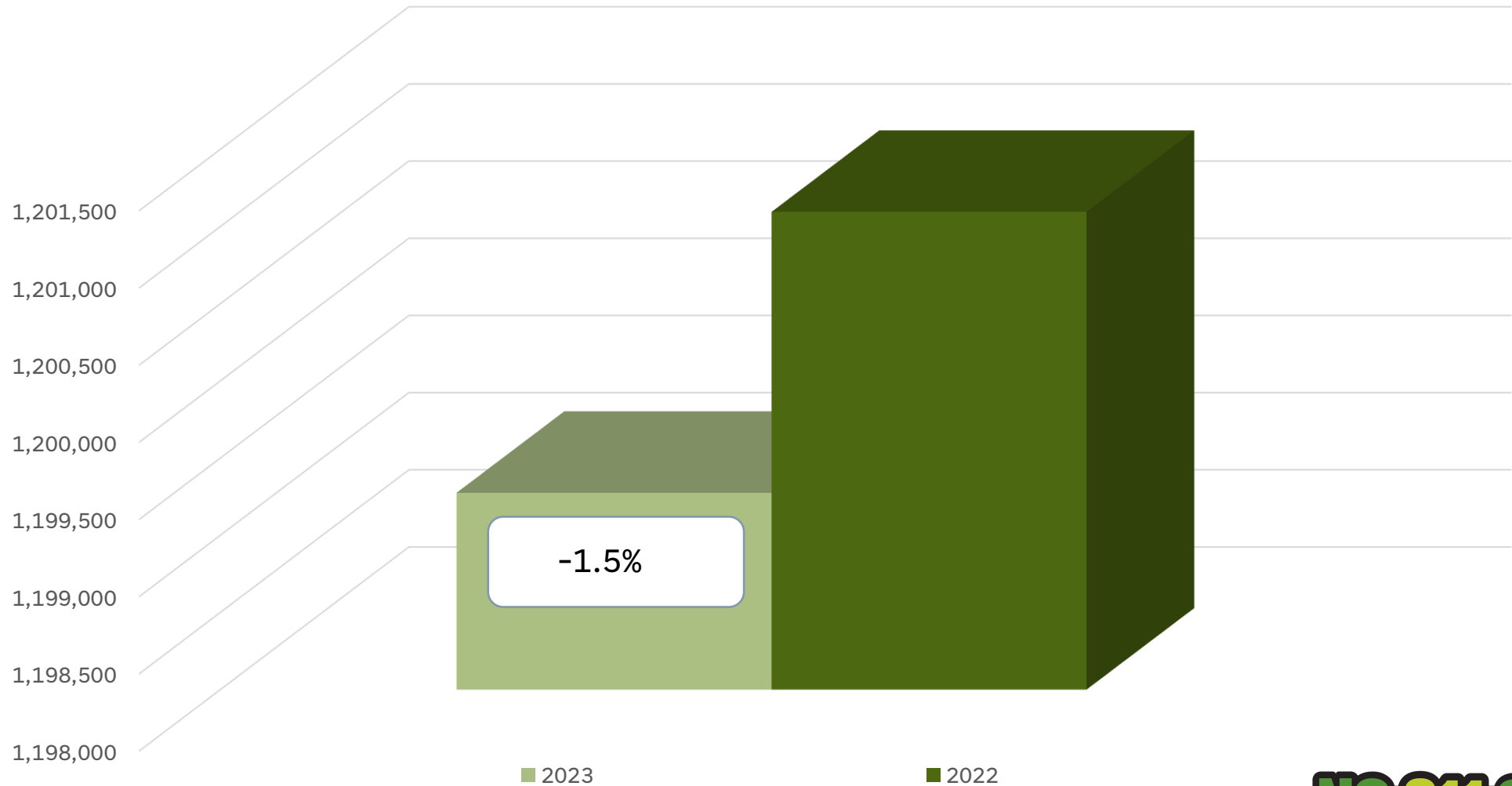

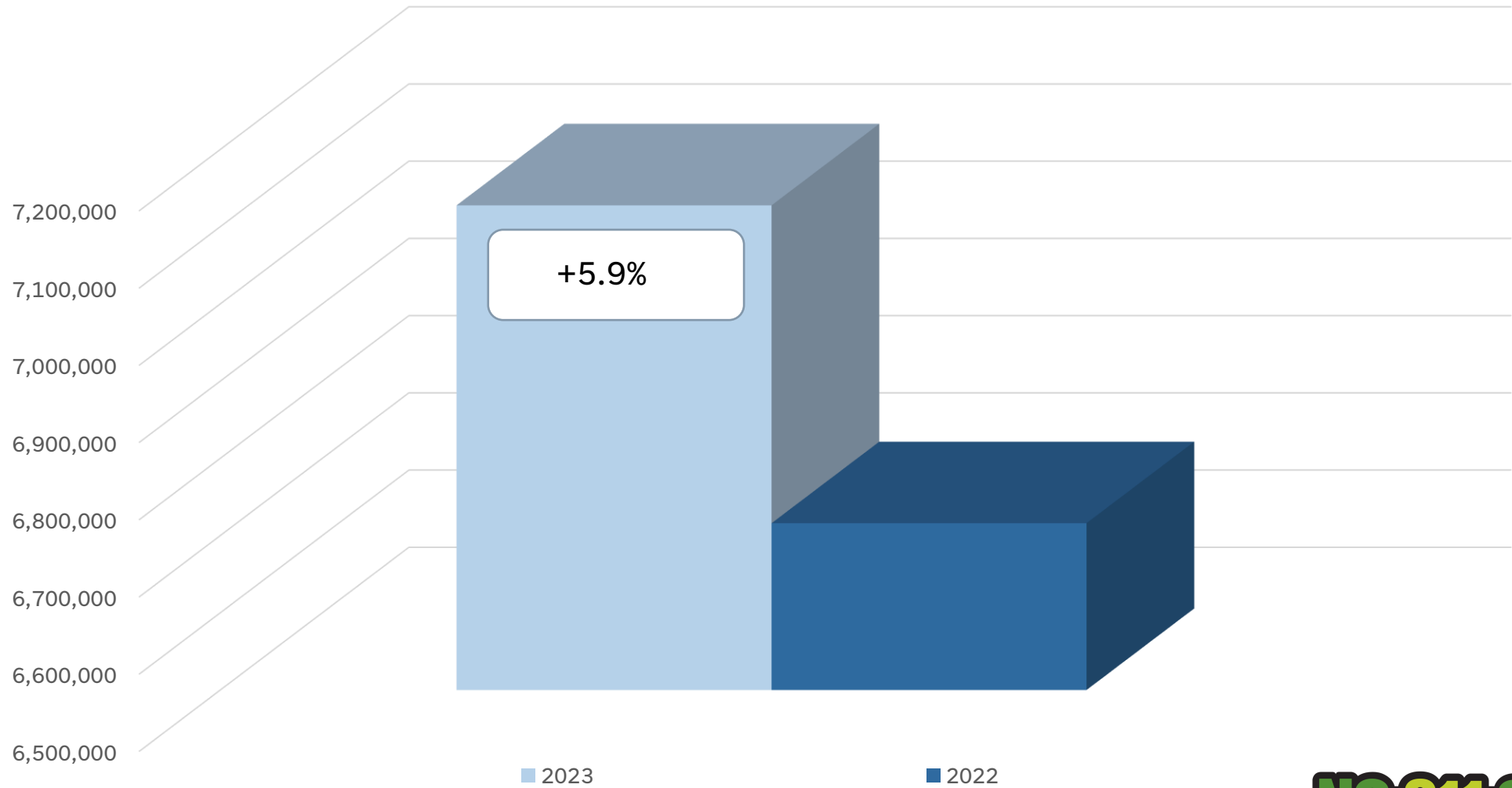
