Discussion:

Parrish with NC811 presented the NC811 report. He discussed upcoming events for July and these are included in the presentation. He mentioned that Paradigm is doing some training, if you would like to attend you can go to their website to sign up. Parrish presented some Hot Weather Tips to keep everyone safe; he showed a video about a construction worker who died after his 2nd day of work from a heat related illness. Employers should have a "Heat Illness Prevention Plan" to help their employees stay aware and help each other stay safe. Overall locate tickets were up 6.7% from last year. Harnett County had a 20.3% increase in locates and Johnston County had a 1.2% increase. There were 22 damages reported in Harnett County and 15 in Johnston County in June.

Andrew with SREMC mentioned that they had an issue with the way a locator marked lines, they sprayed a circle and put 6 marks on the ground; they called the locator back out and resolved the issue.

Lenetta with Town of Clayton asked what you can do if the same contractors/utilities are calling in the same locates multiple times and no work is being done yet. She is having an issue with a telecommunications company repeatedly calling in locates for the same areas throughout an entire subdivision but they are not actively working.

Andrew reminded everyone to white line and to invite contractors to our meetings, he then adjourned the meeting.
