Help us share this message by utilizing our 811 Day Awareness Toolkit.

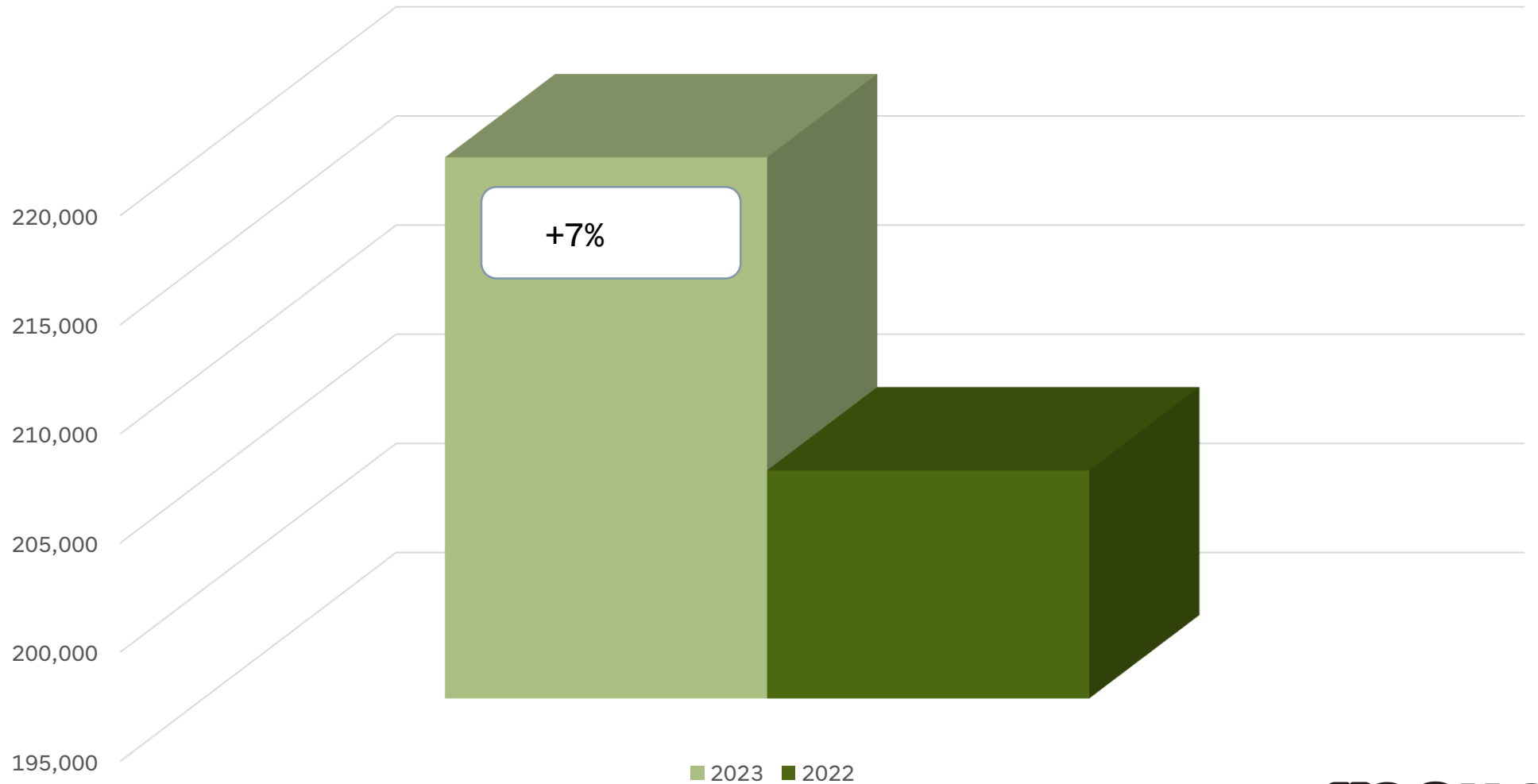

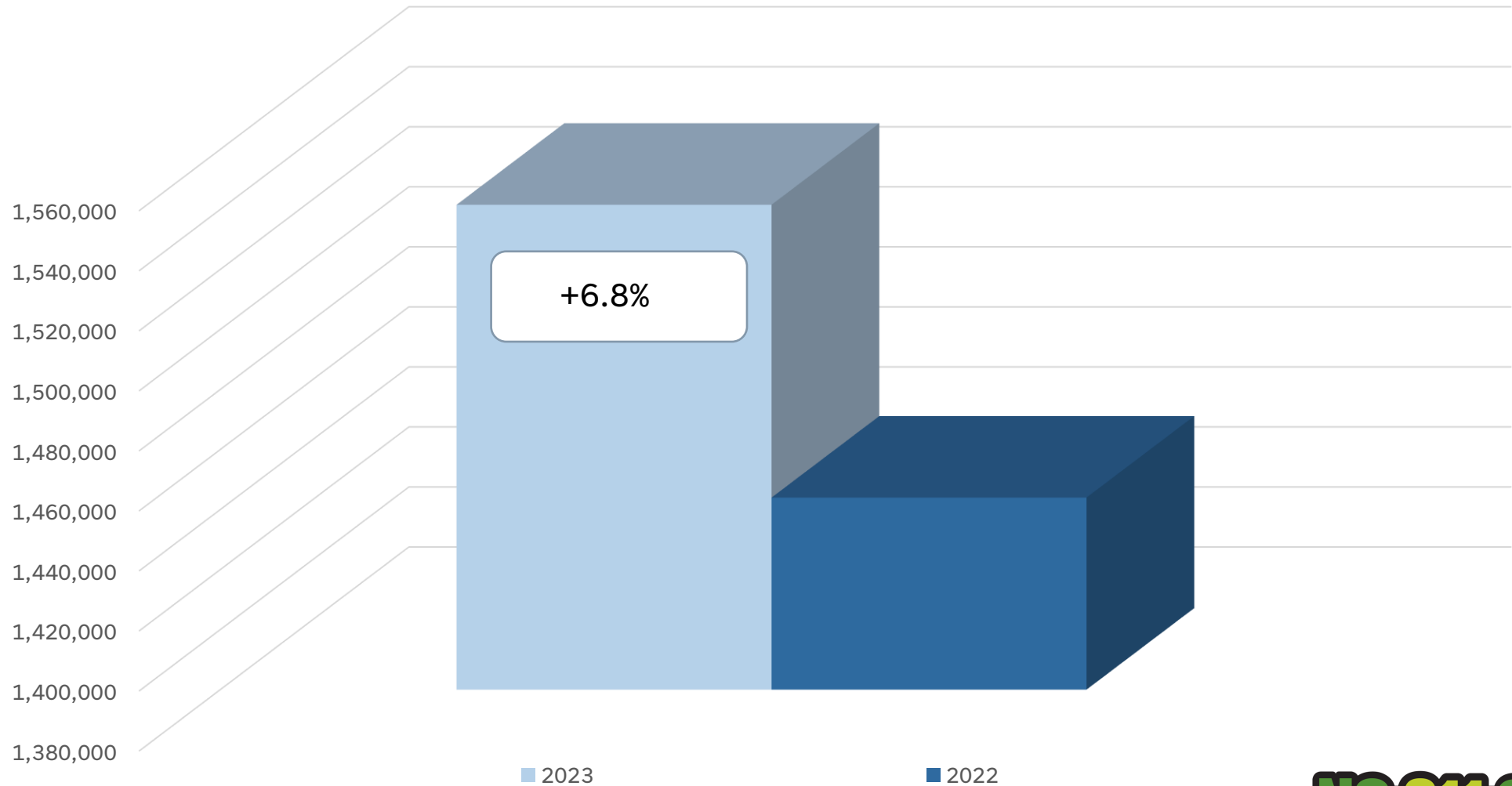
Locate Requests for NC

JULY 2023 vs 2022



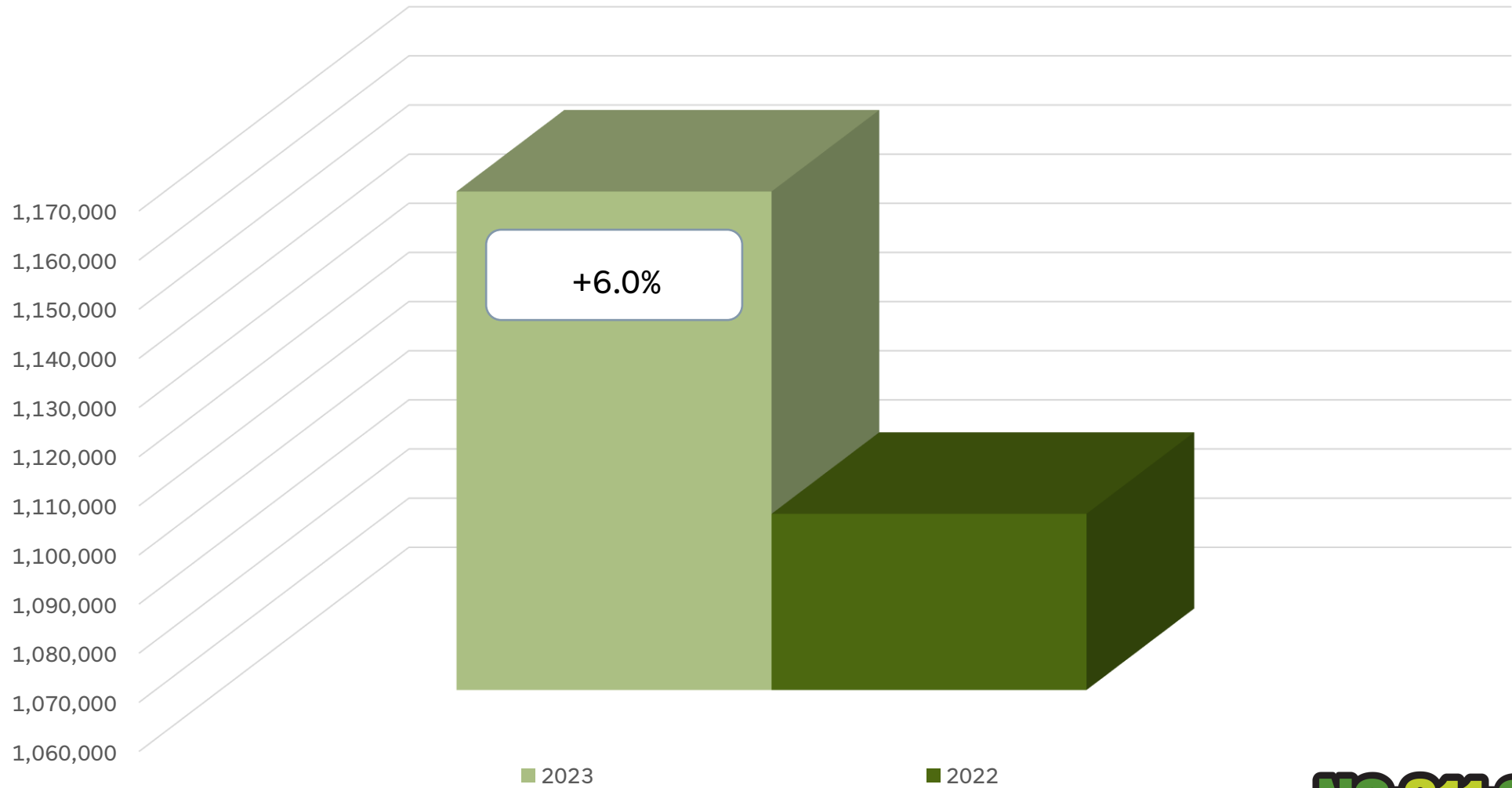

YTD 2023 vs 2022



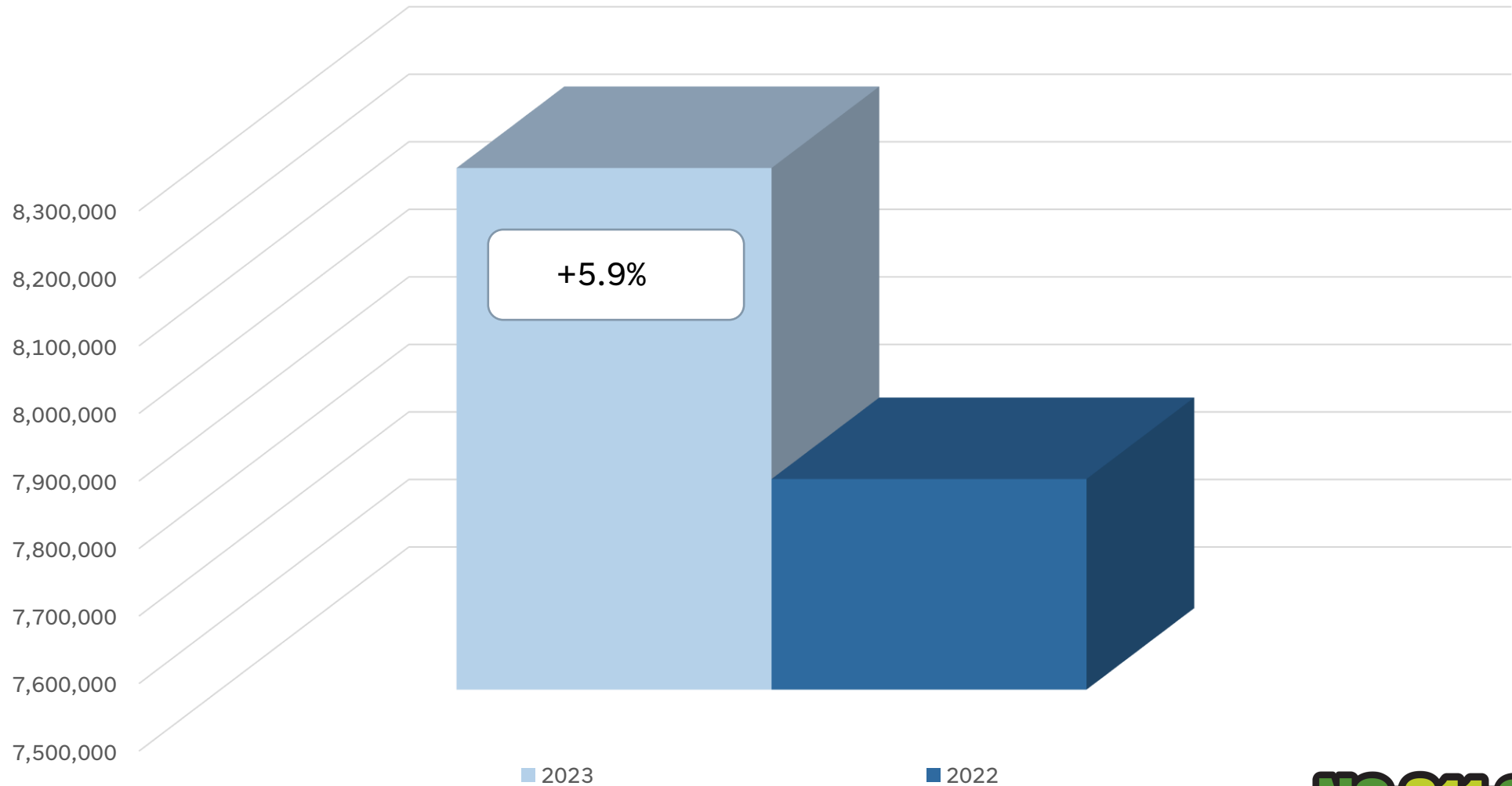
Transmissions for NC

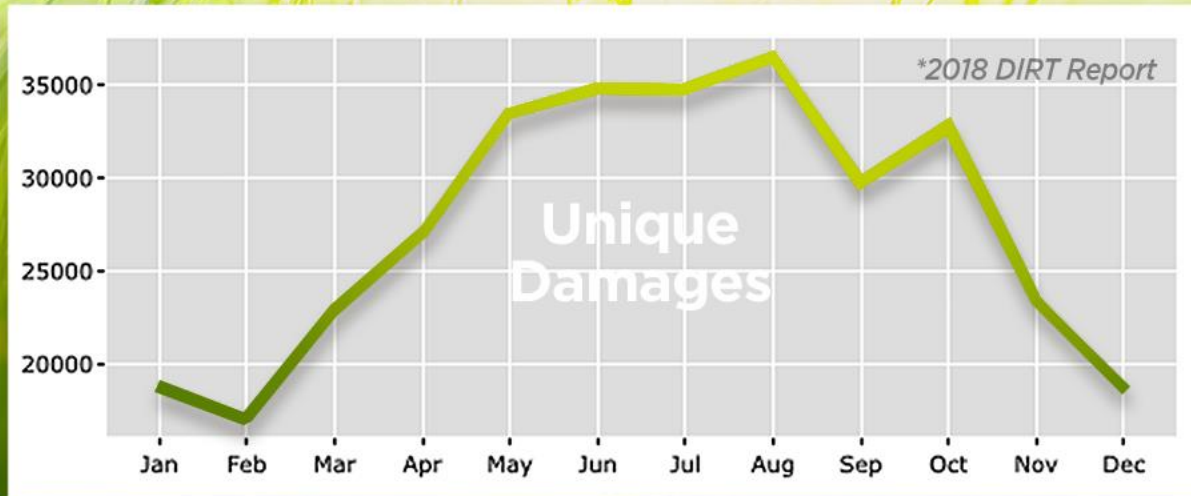

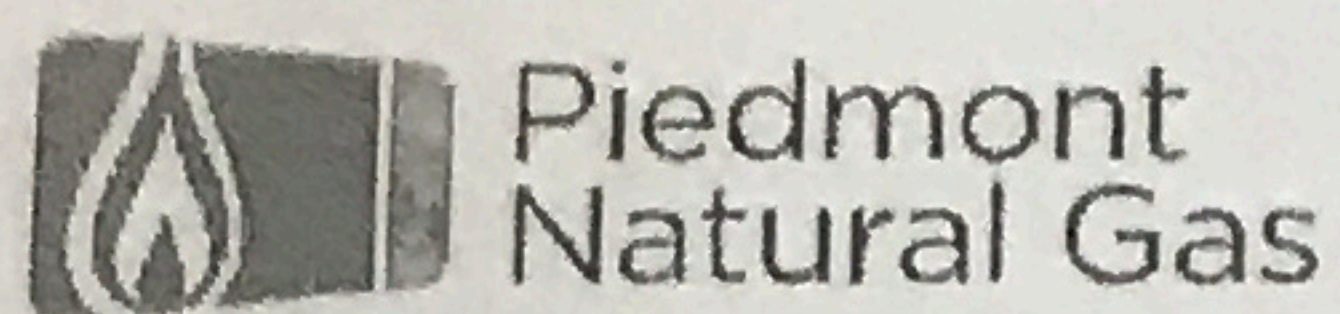
